Sunday Morning Horse Club

10am till 1pm - \$50 per attendance – Beginners Welcome! Ages 8 to 13 – Limit 8 children per date.

Sunday Horse Club is beginner friendly (though we suggest that you take a couple of private lessons to familiarize yourself with the horses and barn). We will meet two Sunday's per month. We have a group riding experience and care for the horses. We learn all about horses, how to groom, tack, bathe, clean stalls, feed them etc. This club is perfect for your horse loving child! Clubbers will be welcome to volunteer at our shows, attend special trail rides and other horse events. Saturday Saddle Club

2pm till 5pm (may differ) - \$40 per attendance – Next Level Up. Ages 10 to 16 – Limit 6 children per date.

Saddle Club meets two Saturdays per month for three hours. This club is designed for students who are already taking weekly horseback riding lessons (from any barn) and can ride independently in those lessons. It is an intensive riding club which will focus on improving your horsemanship. You will be riding in a group lesson and horse care is still required. We will be riding horse show patterns and learning showmanship. We will be attending and participating in horse shows (if the clubber wishes) and our Saddle Clubbers will learn how to prepare a horse for shows and what to expect when showing a horse. Saddle Clubbers will have additional opportunities to attend clinics, trail rides and even camping with the horses. Club Little Foot

10am till 11am - \$30 – For the Beginner younglings ages 6 to 8.

Attendance is limited to 6 or 8 clubbers per club date. Please register early to ensure you have a spot! Text Alisha 727-637-3022 with the date and child's name and she will add your child to the calendar. No name? Not registered. Please make sure you are registered because if you just show up, your child might be disappointed. We hate disappointing children.

A riding boot with a half-inch heel should be worn while mounted. Students MUST provide their own boots. Boots are mandatory for Saturday Saddle Club Members. Other clubbers are allowed to wear any closed toe shoe (sneakers) if boots cannot be obtained. No flip flops or sandals. If you have new boots bring comfortable sneakers to wear while not mounted.

SEI/ASTM certified Riding Helmets must be worn while riding. It is recommended that the student obtain their own helmet. No Bike Helmets! Helmets can be purchased at Amber Glen Feed Depot, Largo Feed and Oak Hollow or Online. We have helmets that clubbers can borrow. If you purchase your own, please write your child's name inside.

Long pants must be worn for riding. Children can bring shorts to change in to. We encourage children to bring extra clothing and a towel as we sometimes get wet bathing horses!

We do clean stalls. We believe that children should care for the horses in order to get the full equine experience. There are fans in each stall and in the hall ways to cool off. We have a snack machine that has cold water for .75 or please pack plenty to drink and snack on.

You must sign a liability release form and medical release form before riding. Both Parents/Legal Guardians must sign the form before children can ride.

Club fees are due when you drop your child off at club. Discounts are only allowed for active students. This means that the student is taking three or more private lessons per month on top of attending horse club. Please confirm your discount when registering for club.

I understand that the activities in which I participate are inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property, and/or death; that horses by their nature are prone to kick, bite, shy, buck, stumble, bolt, rear, or exhibit signs of general unpredictability, and that the land may pose such dangerous conditions due to snakes, insects, ditches, erosions, sharp rocks, culverts, fallen trees, branches, snow and mud, or other natural and man-made hazards. On behalf of myself, my heirs, assigns and next of kin, I waive all claims for damages, injuries and death sustained to me or my property that I may have against aforementioned released parties to such activities.
