DISPLAY PLOTS ON GROUNDS

1. Space allowed is generally adequate for a 10 x 10 tent, except for farm machinery displays. Other requirements by special arrangement.
2. Cost of display plot is \$125.00. Credit allowed for amount spent on catalog advertising. Fee for display plot must be paid with catalog advertising fee, or if arranged for after catalog is printed, at the time the display plot is reserved.
3. Cost of display inside Quonset Hut is \$150.00
4. Lions club pavilion is available for display booths for additional charge.
5. Displays may be setup beginning Wednesday prior to fair and must be in place by 8 a.m. on Friday. Displays must be removed by Sunday evening following the fair.
6. Power for lighting will be furnished up to tent or display.
