

**Recycling Coalition of West Virginia
Committee Meeting Minutes
December 7, 2018

The meeting was called to order by Chairman Paul Hayes at 10:30 a.m.

Approval of Minutes

Chairman Hayes asked for a motion to approve the minutes from the Oct. 3, 2018, meeting. Carol Throckmorton made a motion to approve the minutes. Her motion was seconded by Kim Smith. The motion carried.

Financial Statement

Chairman Hayes reported that the Coalition had a General Operating Bank Balance of \$6,611.71 as of November 30, 2018. Tom Aluise made a motion to accept the Statement of Condition. The motion was seconded by Carol Throckmorton. The motion carried.

ReFashion Show

Carol Throckmorton reported that Charleston Newspapers increased its donation to the ReFashion Show from \$50 to \$100. CN also provided a free ad. There were 20 participants in the 2018 ReFashion Show.

Adult Contest

Four winners were picked in the Coalition's Adult Contest, each receiving \$25. They were: Addison Elkins, from Lincoln County; Cody Breedlove, from Lincoln County; Misty Jackson, from Kanawha County; and Pat Mashburn, from Kanawha County.

Youth Contest

The Coalition judged and picked the winners for the 2018 Youth Contest:

- Owen Tallhamer was the first-place winner in the Kindergarten – 1st grade coloring category. He is a student at Smithville Elementary in Ritchie County.
- Kinzy Arbogast, a member of the Haer Bears 4-H club in Mason County, was the first-place winner in the 2nd-3rd grade coloring category.
- David Ashman and Dave Carper, from Roane County, were the co-winners in the 4th-6th grade age group of the Freedom Contest. The boys worked together to study the dragonfly before making a dragonfly sculpture out of an old table leg spindle, door knob, hangers and repainted ceiling fan blades.
- Gweneth Ashman, Kennedy Romine and Cassidy Roush were the co-winners in the 7-8th grade age group for their entry from Roane County. The girls made a sculpture using a pop bottle, shoestrings,

twist ties, a glass pop bottle, coffee filters, clothes pins, beads, a balloon and cotton reused from a pill bottle. The sculpture shows the four stages of life of a butterfly. They will split a \$75 prize for their winning entry.

- Anna Carte, Destiny Smith and Kyannia King, from Roane County, were the 9-12th grade age category winners in the Freedom Contest. The girls embellished some wood with solo cups, coffee filters, colored paper and pencils to make a sculpture depicting a festive deer.
