This is a legal contract, which entitles you to display/vend on Saturday and Sunday, September 2<sup>nd</sup> and 3<sup>rd</sup> 2017 from 9:00 a.m. to 6:00 p.m. In return for the use of the space assigned to you by the Hood Canal Highland Celtic Festival (HCHCF), you hereby agree to abide by all rules and regulations stipulated below. In return, the HCHCF promises to promote and advertise this event.

**RULES AND REGULATIONS**

1. The Festival provides space only. No trailers or motor homes will be permitted on the grounds except for food preparation booths as required by the Health Department.

2. Changing booth locations after assignments will not be allowed (without permission of the HCHCF).

3. Local police will not provide extraordinary patrols of the Event grounds. Night security guards may be on duty Friday and/or Saturday evening. The HCHCF and its organizers cannot be held responsible for loss or damage. Clans are responsible for securing booth and products.

4. Each Clan must park their vehicle in designated parking area after unloading for the day.

5. Clans will receive gate passes (bracelets), which must be carried at all times; replacement provided at a cost of \$7 per pass.

6. The Games are two days - Saturday, September 2<sup>nd</sup> and Sunday, September 3<sup>rd</sup>. Your registration fee is for both days. Hours of operation are Saturday: from 9:00 a.m. to 6:00 p.m. and Sunday from 9:00 until 6:00 p.m., at the conclusion of the Massed Bands performance. Set-up begins on Friday, September 4th at noon. We will have designated times. So please be aware of this new procedure. No take-down will be allowed before closing time on Sunday.

7. Violation of any of the above will result in eviction from the grounds.

8. Because booth space fees are committed in advance to pay costs associated with the Festival, there are no refunds for any reason.

9. HCHCF is not responsible for any lost, stolen or damage items, that incurs while you are at the HCHCF. It is your responsibility to be aware of your personal property at all times.
