

VWW Karaoke Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. ELIGIBILITY

- Vallejo Waterfront Weekend (VWW) Karaoke Contest (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia. Employees of Vallejo Waterfront Weekend and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.
- Professional singers, or current recording label artists are not eligible. The Contest is subject to federal, state, and local laws and regulations.

2. SPONSOR

The Contest is sponsored by Vallejo Waterfront Weekend, located at 1525 Sonoma Blvd, Vallejo, California 94590.

3. AGREEMENT TO OFFICIAL RULES

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. CONTEST PERIOD

The Contest hours are Saturday, October 6 from 12 to 3pm for Qualifying, and 3 to 4pm for a Final round (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods:

- On-Site • Online • Via Mail

5. How to Enter

On-Site: This method of entry will be available at Vallejo Waterfront, 289 Mare Island Way, Vallejo, California 94590.

Online: This method of entry will be available by visiting our website (VallejoWaterfrontWeekend.com) and following the directions provided to fill out the entry information, and submit.

Via Mail: This method of entry will be available through October 3, 2018. On a 3x5 card, handprint your full name, complete address, phone number (including area code) date of birth, email address (optional), three karaoke song selections (in order of preference) and mail in an envelope with proper postage affixed to: Vallejo Waterfront Weekend, 1525 Sonoma Blvd, Vallejo, California, 94590. Mail-in entries must be hand-printed and mailed in separately. *All mail-in entries must be received by October 3, 2018.*

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

6. OFFICIAL RULES

- Contestant shall not be signed under an existing recording label contract, or perform professionally as a singer.
- Qualifying round will be on Saturday, October 6th from 12:00 to 3:00 pm at the VWW stage off Mare Island way.
- Contestants shall appear at the VWW waterfront stage area no later than 11:30 am for production instructions and role call.
- Time periods will be filled on a first-come, first slot-select basis.
- Contestants shall provide three potential karaoke songs (in order of preference) to the karaoke jockey prior to the contest.
- Song selection is subject to the karaoke show provider's availability.
- If contestant does not respond immediately when their name is called to perform, they may forfeit an opportunity to win.
- Contestants will be judged by three celebrity judges for Vocal Quality (maximum 10 points), Performance Quality (maximum 10 points), and Audience Interest (maximum 10 points) for a possible total of 30 points.
- The top ten contestants will be asked to perform in the Final round on Saturday, October 6th from 3-4 pm.
- The Final round order shall be selected by random draw by the karaoke provider.
- The use of profanity is strictly prohibited and cause contestant to be disqualified.

7. WINNER NOTIFICATION

Prize winners will be announced on Saturday, October 6th at 4:00 pm. at the VWW waterfront stage.

8. PRIZES

- 1st prize - \$500 • 2nd prize - \$250 • 3rd prize - \$125

9. GENERAL CONDITIONS

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Contest and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

10. RELEASE AND LIMITATIONS OF LIABILITY

- By participating in the Contest, entrants agree to release and hold harmless the Sponsor, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Contest, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Contest, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) lost, late, incomplete, garbled, illegible, undelivered, stolen, damaged, delayed, postage-due or misdirected mail, entries, application downloads, (e) any other errors or problems in connection with the Contest, including, without limitation, errors that may occur in the administration of the Contest, the announcement of the winner, the cancellation or postponement of the event and/or the fly-over, if applicable, the incorrect downloading of the application, the processing of entries application downloads or in any Contest-related materials; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Contest or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties liability will be limited to the cost of entering and participating in the Contest, and in no event shall the entrant be entitled to receive attorney's fees.
- Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest.
- Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

11. DISPUTES

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in California. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants rights and obligations, or the rights and obligations of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of California, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than California.

12. PRIVACY

Information collected from entrants is subject to sponsor's privacy policy.
