Be a recreation therapist, recreator, educator, supervisor, management or administration.** The term of office shall be for four (4) years. The term begins at the annual meeting of CBRPC (March 2020). The 2020 annual meeting will be held in Long Beach California on Thursday, March 12, 2020.

- 1) Shall be nominated by those eligible to vote (Currently certified CBRPC Certificants). Certificants may nominate themselves.
- 2) The slate of nominations must be approval by the board prior to the election ballot being electronically sent to the general membership in February 2020.
- 3) Nominees must agree to run, provide a statement as to why they are interested and how they will benefit in serving on the CBRPC Executive Board and receive permission from their work place (if necessary).
- 4) E-mail verification and candidacy statement will be accepted by the election chair in support of green practices.
