### CUCUMBER AND AVOCADO SANDWICH

1 Large Avocado

1/2 Cup of Sprouts

4oz Herbed Goat Cheese

Squeeze of Fresh Lemon Juice

4 Slices of Whole Grain Bread

1/2 Large Red Onion

2 Leaves of Romaine Lettuce

1/2 Large Cucumber

Spread the herbed goat cheese evenly on all of the slices of bread. Take one of the slices and top with lettuce, cucumber slices, and avocado slices. Drizzle a little fresh lemon juice over the cucumbers and avocados. Add some sprouts and season with salt and black pepper, to taste. Place a piece of bread, goat cheese side down, on top to sandwich all of the fillings together. Repeat with second sandwich. Serve immediately.

#### **Architectural Control Committee**

Remember to always obtain ACC approval before making changes to the exterior of your home, including any exterior painting, roofing, fence, or driveway replacement. The instructions and application can be found on the Crest web site noted above. The name of the application has changed it is now known as the Exterior Modification Request. We currently have four committee members and would like to add additional member. If you are interested, please contact any Director for assistance.

Trash & Recycling Services

Trash service is Monday and Thursday. Recycling service is Wednesday. Bagged landscape cuttings and leaves no longer need to be left on the curb. Instead, they will be picked up with regular household trash, which is currently a maximum of six bags not exceeding 40 pounds per pickup. Please advise your landscape contractor of this change. Tree trimmings and branches will continue to be collected at the curb - cut in length not to exceed four (4) feet, securely tied in bundles and not weighing more than forty (40) pounds. Our recycling scope is unchanged, they are not accepting glass. A more detailed description of these services is on our website, www.countryvillagehoa.org

**Community Center** 

Improvements are being planned to both the grounds and the clubhouse this year. Upcoming topics include updating the Clubhouse interior and furniture, improving the grounds, and the potential addition of a dedicated dog park, walking path, what to do with the tennis courts and/or pavilion. We will be relocating the storage shed so the basketball court can be refurbished. To aid in these efforts a number of committees for the Community Center revitalization projects has been established and are meeting on the subjects.

Kirkwood Paving and Drainage Project update

Construction continues on the west side or south bond lanes. The entire project is scheduled to be complete end of May 2022.

Irrigation systems: The contractor is required to repair/replace individual irrigation systems and interior drain lines of all residents that go through the curb that are damaged as they install the new sidewalk and curbs. Residents are encouraged to take pictures of the existing systems to help the contractor with the restoration.


Mailboxes: Residents were notified in June 2018, that changes in the road required their mailbox, which is in the City's right of way, to be relocated and replaced. The replacement is similar to typical black mailbox on a wood post. There will be no cost to the Owner. The City has advised if the resident wishes to build a new brick mailbox they may do so at their own expense.

Streetlights: New Street lighting is included in the project. Streetlights are installed by CenterPoint and will be done at the completion of the entire project.



#### **Pool Parties and Groups**

Residents may bring four (4) guests per household and are responsible for their guest's behavior. Guest are required to exit the pool when the resident leaves. You cannot check guests if you do not plan to be there with them.

If your group will have more than four (4) guests or if you are planning to host a poolside party, please contact American Pool at 281-916-0020 for reservations. Please note, residents wishing to host a gathering at the pool may be required to reserve a lifeguard to ensure the safety of their group/party guests. For all other pool related questions or concerns, please contact Crest Management.



#### Pool Key Fob

Pool access is controlled via key fob. Please contact Crest Management to acquire a key fob or if your existing key fob is not allowing access. You can also request access via your homeowner portal on the Crest website.

#### **Pool Safety**

Please familiarize yourself with the rules for the Country Village pool, they are designed for all our safety. The entire list is posted at the pool and can also be found online at: http://www.countryvillagehoa.org/pool.html or on the Crest webpage TBD.

Based on feedback from last season, please pay particular attention to the following:

- No running, pushing, shoving, or horseplay on the pool deck. Please ensure the children under your supervision are not running or horse playing.
- Only children 5 years and under are allowed in the wading pool; parents are responsible for supervision of their children in the wading pool. The lifeguards do not guard the wading pool, please stay with your children.
- Children requiring diapers must wear swim diapers. A regular diaper breaking in the pool will require the pool to be closed for cleaning.
- Children under the age of 12 must be accompanied by an adult (18 years of age and older).
- No glass containers of any kind are permitted within the pool enclosure. Broken glass in the pool will require the pool to be closed for cleaning.
- Pool gates lock at 8:00 pm, Lifeguards will ask swimmers to prepare for closing 10 minutes prior.
- Lifeguards have FULL AND FINAL authority to maintain order, discipline, restrict and evict any individual not complying with the rules.
