Dear Friends of Parsonsfield:

It has been a privilege to serve the State of Maine since being sworn into the U.S. Senate.

Much of my time in Washington this past year has been devoted to the Senate Armed Services Committee and the Select Committee on Intelligence. Protecting our homeland and the people of Maine from terrorism and violence remains one of my top priorities. Through my work on the Armed Services Committee, I was able to secure several provisions in the 2016 National Defense Authorization Act that benefit Maine. The legislation authorizes the construction of an additional DDG-51 Arleigh Burke Class Destroyer that could be built at Bath Iron Works and expands the HUBZone program to stimulate economic growth at former military installations like the former Brunswick Naval Air Station.

Returning control to teachers, school districts, and states has also been a primary concern of mine. I am encouraged that the Every Student Succeeds Act has become law. It eliminates the burdensome requirements of the No Child Left Behind Act and ensures access to a quality education for all students. A provision I helped author in the bill will give states the opportunity to pilot the use of their own proficiency-based assessments in lieu of federally-mandated standardized tests. Also included in the bill are several measures I secured to promote local input, fund education technology initiatives, and explore new strategies to increase student access to the internet outside of school.

Communities across Maine have taken bold action to improve their broadband connectivity, and I have been proud to foster federal support for these types of projects. My amendments to the Every Student Succeeds Act will promote the type of work already occurring in Washington County, where students who lack broadband access are able to check out mobile hotspots from their local libraries. Additionally, a bill I cosponsored, the Community Broadband Act, helped pave the way for the FCC to enact rules protecting the ability of municipalities to invest in better broadband. I am excited by Maine's leadership on this important economic development issue and will continue to support local efforts in this area.

After extensive negotiations, the Senate passed a five-year transportation bill that will increase highway and transit funding in Maine and provide stability to improve our transportation infrastructure. The legislation contains provisions I cosponsored to cut red tape and improve predictability and timeliness by streamlining the federal permitting process for large infrastructure projects. Also incorporated in this bill are my provisions to relieve financial regulations on Maine's community banks and credit unions and to reauthorize the Export-Import Bank, a critical tool that supports communities and small business across the state.

Following my inquiries in the Energy and Natural Resources Committee, the National Park Service has announced they will begin exploring strategies to allow park visitors to purchase electronic passes online and will pilot the program at Acadia National Park. These passes would improve access to our nation's most treasured landscapes and would generate resources for years to come. I remain deeply engaged in preserving Maine's natural beauty and strengthening our outdoor recreation economy.

It is with solemn responsibility that I have focused my energy addressing the opioid epidemic in Maine. This work includes convening roundtables with a wide-range of health care and law enforcement professionals to combat addiction; introducing a proposal to safely dispose of excess prescription drugs; cosponsoring a

Senate-passed bill that addresses mothers struggling with addiction and the alarming effect it has on newborns; cosponsoring the TREAT Act, which expands the ability of medical specialists to provide life-saving medication-assisted therapies for patients battling heroin and prescription drug addiction; and calling on the Commander of U.S. Southern Command to increase efforts to stop the flow of heroin at our southern border.

### Parsonsfield Recycling Committee Report for Year Ending June 2016

The Parsonsfield Recycling Committee (PRC) wishes to thank the staff of local businesses, and all residents who recycle the <u>first</u> and <u>third</u> Mondays of each month. Weekly recycling pickup dates and informational ads are listed in the weekly Shopping Guide. Remember that recycling is mandatory for all residences and businesses, and saves taxpayers approximately \$82.99 per ton since recycling is not charged tipping fees. TRASH AND RECYCLING ARE NOW PICKED UP ON FRIDAY.

The following report summarizes the recycling efforts and activities of the PRC, town residents, and businesses, during July 2015 - June 2016.

White Goods Pickup - Once each spring, Mellen and Sons picks up white goods curbside. Items include stoves, refrigerators, freezers, etc. from town residences. Please purchase Freon stickers at the Town Office which are needed for refrigerators. Spring tonnage = 2.22 Tons

\*An important reminder: Plastic bags and Styrofoam are not recycled at Ecomaine, so please do not put them with your recycling.

Please look for other Recycling information that is posted on a bulletin board in the Town Office.

The annual Bulky Waste Pickup (couches, mattresses, furniture, etc.) in Oct. was 4.5 Tons.

Tires collected through drop-off and taken to Riverside Recycling in Portland amounted to 3.77 Tons.

Parsonsfield/Cornish had an electronic waste collection in spring of 2015, but did not have one this spring due to increased fees from the vendor for setting up the collection site and for increased charges for items recycled.

I am writing to respectfully request support from the Town of Parsonsfield which, if granted, will be restricted for the purpose of helping to fund Caring Unlimited's direct safety planning and support services for victims of domestic violence and abuse during the coming fiscal year.

There can be no doubt that domestic violence is a serious problem locally. According to their latest crime stats Maine's Department of Public Safety reports that the state's highest number of reported domestic assaults occurred in York County for the third year running (*Crime in Maine 2013, p. 32*).

Caring Unlimited remains the only organization in York County to which a resident of Parsonsfield can turn twenty-four hours a day, 365 days a year for vital safety planning and emergency support services when in danger from an abuser. CU's 24-Hour Hotline, Emergency Shelter, Transitional Housing, Outreach Services, Legal Assistance, Youth-Focused Prevention and Community Response Programs are available at no cost to Parsonsfield residents whenever they need them.

HomeHealth Visiting Nurses appreciates this consideration for funding in fiscal year '16-'17. Last year, the Town of Parsonsfield provided \$1,500.00 to support its residents in need of home health and community care services. We are grateful for this support and respectfully request that the Town of Parsonsfield consider, once again, \$1,500 to help offset this year's charity and uncompensated care of \$2,451.00.

### History

HomeHealth Visiting Nurses (HHVN), a licensed 501(c)(3) not-for-profit organization, is the leading provider of home health services in Southern Maine. The organization was established in 2004 through the merger of Community Health Services with Visiting Nurse Service, which respectively served Cumberland, York counties and southern Oxford Counties. In 2011, HHVN merged with Southern Medical Center (SMMC) Visiting Nurses who shared similar mission and service area.

### **Program Services**

Our home-based healthcare services which include skilled nursing, physical, occupational and speech therapies, home health aides, counseling, and palliative care allow patients and families to receive necessary and cost-effective health care in the comfort home. In addition, our presence in the home allows clinicians to identify and address needs such as fuel assistance or inadequate food and nutrition and potential abuse or neglect.

Our Community Health and Wellness clinics offer essential health education, health promotion, diabetes education, medical screenings and tests, foot and nail care, disease detection, monitoring and referral services. Clinics are open to anyone age 18 or older, with flu shot clinics open to all 6 months and older. The majority of our clinic clients are elderly, over age 60. The clinics allow us to provide health care services in community settings where elderly residents are comfortable and have easy access to care and serve as an important referral source to other services.

HHHV is the lead provider of home based pediatric services offering two distinct programs. Our Parent and Child Health program serves new mothers, infants and children with special needs, and is paid for with state grant funds. This grant allows us to offer these services at no charge. We are the only agency providing these valuable services to new families. Our Skilled Pediatric Program provides a full range of home health services to medically fragile children, many of whom are facing the challenges of cancer or other serious diseases.

HHVN transitioned to a new generation of Telehealth equipment that includes a 4G internet enabled Tablet featuring video education, assessment questions, blue tooth peripheral devices, and capacity for video visits between patient and nurses.

### Agency Highlights

Our commitment to patient focused care is shown by the latest publicly reported findings from the Consumer Assessment of Healthcare Providers and Systems (HHCAHPS). On the following four measures we rated above the State and National averages:

### **Funding Need**

As a not-for-profit home health care organization, we have the privilege and responsibility of serving those patients who might otherwise not receive necessary health care. Each year, town contributions allow us to provide free and reduced fee health care to residents who lack insurance or other resources to pay for care. Town funds help us leverage funding from other municipalities. In addition, having support from the towns we serve helps us garner support from other funding sources. We are grateful to be the recipient of United Way funds, grant funds and volunteer hours to help us make the most of the municipal funding we receive. However, the funds and in-kind support we receive are a small percentage of the total amount of free and reduced-fee care that we provide. In FY15, our charity care and uncompensated care was more than \$900,000.

As the enclosed statistical summary indicates, we cared for 60 Parsonsfield residents last year, for a total of 398 visits and tests. Our commitment to serving Parsonsfield remains strong. We continue to seek and receive referrals from area hospitals, assisted living facilities and physician offices. In delivering this care, we provided \$2,451 of charity/uncompensated government care to residents of Parsonsfield.

RE: Update to Donor Municipalities from LifeFlight

**Dear Parsonsfield Residents:** 

Thank you so much for helping LifeFlight provide expert care and swift transport for people in Maine when medical emergencies occur. In cooperation with your local Fire, EMS and Emergency Departments, LifeFlight connects your community with the major medical centers in Lewiston, Bangor, Portland and Boston.

Your unrestricted donation helps purchase aircraft, medical equipment, aviation infrastructure around the state and fund advanced medical training provided by LifeFlight for your local medical personnel.

Over one quarter of municipalities in Maine have made voluntary donations to support this nonprofit public service—a testament to the trust people have in LifeFlight's commitment to safety and to serving any person in need, regardless of ability to pay.

This year, LifeFlight is closing in on the acquisition of a third helicopter. Adding this aircraft directly addresses a capacity issue that has been growing 10-14% yearly: as people in Maine rely more on LifeFlight for advanced, life-saving treatment of trauma and serious illnesses and fast transport to specialty surgeries and physicians, the number of requests has grown beyond our ability to respond to all of them. In the first nine months of our current fiscal year, we were unable to answer 487 calls for help because our current aircraft and crews were busy with other patients. This acquisition not only addresses the present problem, but will allow LifeFlight to respond to increasing need for years to come.

The Town of Porter has received a grant of \$3000 from the DEP to remove the invasive aquatic plant variable Milfoil from a section of the Ossipee River between the NH line and the dam in Kezar Falls. Last summer, the Porter Conservation Commission and a group of volunteers from both Parsonsfield and Porter mapped the location of the milfoil and developed a plan for removal by a professional diving company this summer.

Much of the milfoil is located near the dams in Kezar Falls with a large portion of the weed close to the Parsonsfield shore. This eradication effort will require consistent monitoring and further removal, but failure to take action will result in the eventual loss of use of this section of the river and a dramatic change in the appearance of the river.

The Town of Porter, with the full support of the Conservation Commission and the Select Board, has raised \$2000 for the required match to the grant. The Conservation Commission and the Select Board of Porter respectfully request that Parsonsfield consider contributing \$1000 as a part of the match for the grant.

We hope that you will give this request your careful, and hopefully favorable, consideration.

#### PARSONSFIELD-PORTER HISTORICAL SOCIETY - ANNUAL REPORT 2015

2015 was one of the busiest seasons the Historical Society has had. Something was going on almost every weekend from June through September. The same slate of officers was elected at our April business meeting: President – Sylvia Wilson, VP – Lynda Sudlow, Treasurer – Merry Shea, and Secretary – Jan Iler. Sadly, our Treasurer, Merry Shea passed away in December leaving the Treasurer position vacant. Sylvia Wilson filled in during the last few months and would be willing to take the Treasurer position in 2015 as she would be happy to pass on the President position to someone new. Therefore, we need some new members to come forward for elections in April. Would you be interested and willing to take an officer position? Please give it some thought and let us know.

Meetings are held once each month from April through October (except August) usually the 4<sup>th</sup> Saturday of the month – but watch the shopping guide to be sure of the dates and locations. Most are held at History House on Main Street. All the meetings are open to the public and five have interesting programs. There will be two open house dates – June 4 and Sept.18 that feature the new exhibit for the season. Many of our programs are presented by Society members willing to share their pictures and knowledge of local history. At the 2015 September open house the scrapbook collection was brought out and visitors had fun browsing through them.

In 2015 we changed our practice of doing a whole new exhibit in the Meeting Room every year. Instead, there will be a smaller major new exhibit in one section and small semi-permanent exhibits around the rest of the room. In 2015 the main exhibit was "Coming Home - 1865" about our veteran's lives after the Civil War ended. This was to commemorate the 150<sup>th</sup> anniversary of the ending of the Civil War. The rest of the house is also open for tours.

Our collection at History House continues to expand as does the research material, photos and genealogy information. The research room is available May through September on most Mondays from 10:30 - 1:30 and by appointment. It is best to call a day or two ahead to be sure.

Part of our mission is to encourage local schools to bring pupils to History House to learn about our local history. In 2015 forty plus 5<sup>th</sup> Grade students from South Hiram Elementary School came to tour History House.

We are gradually expanding our activities beyond History House with tours and opportunities for the public to learn about historic places and people throughout Parsonsfield, Porter and South Hiram. Again this year Peter Cyr generously held open house at the historic Blazo-Leavitt house in North Parsonsfield, and Silas Haggerty graciously invited us to the former Playhouse Theater in Kezar Falls, Open House at the Parsonsfield Townhouse in Middle Road was held again in August and Open House at the Old Porter Meeting House was held in September. New in 2015 was a mock school day at the old Blazo School House on Par Sem Day. Also new this year was a three part program/workshop "Documenting Your Family History"— an introduction to digital scrapbooking. Two of these were hands on workshops to learn how to research your family information via the internet and then setting up a digital scrapbook page of your own.

Fundraising is important to the survival of the Society and is done through — catering a supper for an Oxford County Municipal Officers meeting; yard & bake sale; exhibit at the Ossipee Valley Fair; a quilt raffle; the sale of books published by us; a booth at Par Sem Day and at the Apple Festival. The books "Parsonsfield, Maine — a Town of Many Villages" and "Porter, Maine — 200 Years" are still available. These continue to be popular.

Don't forget to check the BLOG Local History Matters by Patricia Turner for interesting historical stories and more information about PPHS. We also receive many inquiries for information through our web site and e-mail address.

Traditionally we end the season in November with our members and invited guests sharing a Thanksgiving Pot Luck Luncheon. It is always a nice way to end the year.

Planning for 2016 is in progress. We will have some exciting new programs, so watch for ads and notices of our meetings in "Your Weekly Shopping Guide" beginning in April or check the schedule on our BLOG.

We want to thank everyone who has supported the Society and taken an interest by attending our meetings, open house dates and fundraising events. Do you like local history and have some time to spare? Come see what we are all about.

### THE SOUTHERN MAINE AGENCY ON AGING – WHAT DO WE DO?

Since its founding in 1973, the Southern Maine Agency on Aging (SMAA) has provided residents of York and Cumberland counties of Maine with resources and assistance to address the issues and concerns of aging. The Agency staff of 120 and corps of more than 600 volunteers serve 25,000 people each year. SMAA's many programs and services are designed to help meet our mission of improving the quality of life of older adults, adults with disabilities and the people who care for them.

Older and disabled adults and their caregivers benefit from how the Agency addresses: hunger and nutritional health, economic challenges, care management issues, long-term care planning, health challenges, caregiving challenges, and financial fraud and exploitation of the elderly.

The Agency works collaboratively with many partners including Legal Services for the Elderly and other social service organizations, to maximize its service and recruits and supports a corps of volunteers who work for both Agency programs and in the larger community with other nonprofits.

### **HOW DO WE SERVE PARSONSFIELD RESIDENTS?**

Last year, the Agency served an estimated, unduplicated total of <u>63 Parsonsfield residents</u> through a myriad of services, classes, support groups, counseling, nutritional support, and more. <u>The value of the services provided to Parsonsfield residents last year totals \$16,317.</u> Last year:

- 5 residents received guidance, participated in classes and/or support groups to help better understand and manage their caregiving role through the Family Caregiver Support Programs;
- 21 residents received Medicare and other insurance counseling. In addition to helping choose the best coverage for each individual, volunteers assist in saving participants hundreds and often thousands of dollars on yearly insurance and prescription costs;
- 30 Parsonsfield residents received assistance through the Agency's Information and Resources program staffed by 16 social workers who work with seniors and their families by phone or in-person to provide information and support, and to increase access to available benefits;
- 3 Parsonsfield residents received 36 monthly allotments of 30 pounds of shelf-stable food through the Commodity Supplemental Food Program;
- 16 Parsonsfield seniors enjoyed 182 nutritious meals and vital socialization through the Agency's "As You Like It" and Community Café congregate dining programs;
- and 8 Parsonsfield residents received 1,014 home-delivered meals, safety checks, and vital socialization through the Meals on Wheels program.

# WHY SHOULD THE TOWN OF PARSONSFIELD CONTINUE TO SUPPORT SMAA THIS YEAR?

Nationally, over 10,000 Baby Boomers reach the age of 65 every day. Here in Maine – the oldest state in the nation – between 2008 and 2020 it is forecasted that our population of adults age 65 and older will increase by 58% in Cumberland County and 70% in York County for a total increase of 43,547 people in the two counties.

This trend is also true for the community of Parsonsfield. Between 2000 and 2010, Parsonsfield's population of adults 60 and older **increased by 38% or people**. How will the community of Parsonsfield prepare for the needs of its growing senior population?

Maine's older population faces a set of unique challenges. Being a rural community, many older Parsonsfield seniors reside several miles from a grocery store, may not have neighbors within walking distance, or live without access to public transportation. Additionally, Maine's weather takes a toll on our older adults, especially those who are trying to continue living independently, in their own homes.

Mainers are dedicated and proud people. Unfortunately, so many of Maine's seniors, despite working hard their whole lives and saving for retirement, are struggling to cover the costs of basic needs like heat, groceries, and medications, while also maintaining their independence and dignity.

Maine communities are not investing in or taking good care of their seniors and are not prepared for the economic, social and political instability that will ensue as the population continues to grow rapidly.

By investing in the programs of the Southern Maine Agency on Aging, the Town of Parsonsfield is also investing in its future, and the welfare of its residents and its economy.

Franchise fees from Time Warner Cable

We are writing to request that the article below be included in the warrant for the next town meeting (2016) and request 100% of franchise fees received from Time Warner Cable.

This year has been another busy one with the student managed TV-2 program. We continue to add an extensive amount of programming events for our viewers. We have also continued to provide programming to those not served by Time Warner Cable by use of streaming web media content. However our current web system is in disrepair, awaiting new agreement funding, that is on its way. Our web channel is currently only able to access archived programming due to this temporary disruption. Anyone with Internet access can view previously broadcast shows, as well as tune in to view live events on the web, as they are happening, as we broadcast using <a href="https://www.Ustream.tv">www.Ustream.tv</a> Again this year, SVHS students continue to work particularly hard setting up live sound and live remote broadcasting from the many school board public forums that took place during the school budget process, school closure meetings, as well as other community and school events. We continue to provide coverage of all school board meetings and were able to record and broadcast all of the town meetings.

TV-2 students continue to work in a classroom format perfecting their skills with these many events, processing community and school events, and updating information for viewers. Students are actively engaged in learning valuable real life TV/Video experiences as they develop skills necessary to manage the public access channel, all usually while broadcasting, "on-the-fly". We are very proud to have provided coverage of SVHS sporting events this past year, and look to always improve on the program. Many students benefit from this educational component created by the TV-2 Community Television Program in the school, several of which have pursued careers in this discipline after graduation. Students are proud to have been able to provide this service to the community of MSAD #55 and the 5 towns. The students should be commended for their hard work, long hours and skills.

The TV-2 Committee, in cooperation with town officials through active negotiations with Time Warner Cable, have come to agreement to renew our current franchise agreement which had expired in 2011. We formed a Franchise Negotiations Committee in September of 2010, consisting of one selectman from each town, and several TV-2 Committee members. The Franchise Negotiations Committee has been working with several outside organizations, to include the "Broadband Expansion Initiative", to explore expanded coverage to the people of all five towns. Time Warner has recently expanded coverage to several areas of the five towns as part of the "ConnectME" grants. As the new agreement was reached, it serves to settle outstanding issues and will provide equipment & facilities improvements to facilitate expansion for residents and improvements to our current coverage even further, to include a web interface. Our biggest hurdle has been operating on a very tight budget, with equipment that was aging, causing the task of recording and broadcasting to become a "band-aid & seat-of-your-pants"

experience, most recently of which has failed. While we sought out legal advice to accomplish a resolution of the franchise agreement with Time Warner Cable, we have come to a successful conclusion in that process. In 2016 we will see the results of our franchise agreement negotiations for a solid resolution and new 10-year agreement in place. We anticipate the grant funds received will enhance the abilities, bringing old equipment up do date, provide a much clearer signal and more access to web capabilities, all things that have previously been a struggle. We have been nearly "out of service" with the current aged equipment, and look forward to replacement, and a thriving program once again, as grant funds are received

This article does not require the town to raise any revenue. The franchise fee is a fee paid by each cable subscriber to Time Warner Cable - above and beyond the regular cable rate - and is returned to the towns. Most municipalities dedicate these fees to the local access station, in our case TV-2. It is our goal to have TV-2 be self-sufficient, and not need to use school funds or request donations from local businesses to maintain operations.

All funds for TV-2 are managed through the MSAD #55 Finance Office and are audited every year with records kept for at least seven years.
