# Poison Ivy: Leaves of three? Let it be!

#### Introduction

Those who experience the blisters, swelling, and extreme itching that result from contact with poison ivy (Toxicodendron radicans), poison oak (Toxicodendron pubescens), or poison sumac (Toxicodendron vernix) learn to avoid these pesky plants. Although poison oak and poison sumac do grow in Virginia, poison ivy is by far the most common. This publication will help you identify poison ivy, recognize the symptoms of a poison ivy encounter, and control poison ivy around your home.

#### Identification

Poison ivy can grow as a groundcover or small bush in woods, fields, at the edges of openings and trails, and pretty much everywhere else. Poison ivy also grows as a vine that climbs on trees, barns, and fences for support. The vine has small aerial roots along the stem that make it look like a fuzzy rope and often has much longer aerial roots as well. Because the plant grows in so many different forms, its leaflets are the best way to identify

poison ivy. The leaflets grow in clusters of three. Hence the old saying "leaves of three, let it be." These leaflets are from two to four inches long with pointed tips. The middle leaflet is usually larger than the others. The edges of the leaflets don't always look the same. They

might be smooth, or they could have teeth. The leaflet surface can be many different shades of green and appear glossy, dull, or in between.

Poison sumac is a small tree that primarily grows on moist sites in the southern and eastern parts of the

state. There are several other species of sumac that are not poisonous at all. Poison oak is a shrub that grows on dry sites, mainly in eastern Virginia. It is usually less than ten feet tall.

#### What Causes the Rash?

All parts of the poison ivy plant, including the roots, stems, bark, and leaflets, are poisonous year round. The blistering rash people get is caused by an oily toxin known as urushiol. The most common way this toxin gets on your skin is when you touch the plant, especially one that has been damaged in some way, such as being stepped on or run over with the lawnmower. The toxin is oily and sticky, and is easily spread around when you touch other parts of your body. For example, if you are weeding a flower bed and pull up some poison ivy, then wipe your face later on, the chances are pretty good that a rash will develop on your face. You also can contract the rash by picking up the toxins from animals, clothes, or other items that have been in contact with poison ivy. And, if poison ivy is burned in a brush pile, the resulting smoke carries the toxins. It is very important that you avoid breathing the smoke of burning wood or brush if poison ivy might be part of the pile.

#### **Symptoms**

Symptoms begin to appear within a few hours—or days—of contacting poison ivy. Your skin might start itching and burning. This is followed by a rash, redness, swelling, and even watery blisters. Contrary to popular belief, the rash from poison ivy is not spread by touching the oozing blisters.

The seriousness of your rash will depend on how much toxin you contact, the degree of your susceptibility, and the length of time it is on your skin. In addition, your sensitivity to the toxin can change with age. People vary in their reactions to poison ivy. Some people have no reaction.

#### **Prevention and Treatment**

If you suspect that you will encounter poison ivy while working or exploring, it is a good idea to wear a long-sleeve shirt, long pants, and gloves. Be sure to wash clothing and gloves after working in an area where poison ivy is growing. And, wash your hands immediately after placing your clothes in the washing machine. Keep in mind that poison ivy toxins can find their way through clothing. Cases of poison ivy have occurred when a person sweat through a long-sleeve shirt, thereby allowing the toxins to absorb through the fabric and onto the skin!

If you know you have been in contact with poison ivy, wash the area thoroughly as soon as possible with soap and cool water. Warm water may cause the resin to penetrate the skin faster. Because skin can absorb urushiol in a few minutes, you may still get a rash, but at least you will have contained the infected area.

Unfortunately, there is no magic cure for poison ivy, and the rash usually runs its course in two weeks or so. But if you have a bad case, those can be two long weeks. Anti-itch creams can help you get through this period. A variety of products are available, and some are better than others. Some very good prescription drugs are available that can be taken to control extreme cases of poison ivy. Preventative vaccinations are also available and should be administered in late winter. There are lotions that effectively block urushiol from touching the skin if they are applied before contact. Forestry Suppliers, Inc. is one source that offers a variety of poison ivy cleansers, lotions, and creams. You can order a free catalog by calling 800/647-5368. Or, visit their website at www.forestry-suppliers.com. Contact your family physician or pharmacist for more recommendations.

#### Control

Poison ivy can be controlled by spraying the leaves and stems with an herbicide mixture that contains dicamba, triclopyr, or glyphosate. Contact your local Extension agent for more information on preparing herbicide mixtures and applying them safely; and always be sure to follow the directions on the product label.

# **2017 Boating Policies and Safety Tips**

We hope everyone is having a 2017 Fun but Safe experience with the Boating Season. Blue Ridge Shores adopted the provisions of the **Virginia Boating Safety Education Requirement** for operation of a motorized boat on Lake Louisa. The Virginia Conservation Police Department has authority to enforce all provisions of State Requirements on Lake Louisa. Just a few reminders for everyone:


- Anyone operating a motorized boat in Virginia must possess a card indicating they have taken the **Virginia Boater Safety Education Class** or the State's Safety Class where the boat is registered.
- Operators must be at least 14 years old.
- Boats must be registered to a member or a non-member occupant who are members in good standing.
- All motorized boats must be registered through the office with current State Registration and Insurance Information in order to have and display a current Association Decal.
- All Non-Motorized Boats excluding a paddle board must be registered through the Association and display the appropriate decal.
- Jet Skis and jet powered boats are not permitted to be on the lake. Jet powered boats registered with the Association prior to August 13, 2011 are exempted from this rule.
- All motorized boat traffic must travel in a counter clockwise direction, unless they are fishing and under the power of a trolling motor.
- All boats that are non-motorized have the right of way.
- All fast moving boats are required to stay off the Shoreline by 100 feet.
- All boats pulling tubes, skis, aqua boards or any other object are required to have a spotter. These activities are limited from 9:00 AM until sunset.
- All boats are to have running lights or navigational lights after dusk or before dawn.
- The Association's Special Assistant to the GM is patrolling the Lake and will issue violations as appropriate and the member affected will be required to attend a Compliance Committee Hearing.
- Should you have questions, require clarification, or a copy of these rules please contact the office.



# **Virginia Boating Safety Class**

Section II, Policies, Rules, and Registration; D. Boats requires that all Motorboat Operators complete this class or an equivalent and present proof of Compliance to receive their boating

registration this year, (2017). This policy has been phased in since 2011 and effective July 1, 2016 all operators of motor boats regardless of age, shall meet the requirements. If you have completed this class in another State and have that certificate of completion, it will meet the BRS requirements. An



operator under direct supervision of an individual who has met this requirement is not required to take this class.

The Office cannot issue 2017 registration/decals unless the above requirements are met and a copy of completion is submitted for your file.

#### **Boat Registration & Slip Rentals**

Please register your boats with the Office to avoid problems on the lake when you wish to enjoy that privilege. We can register your boats via mail for your convenience. As a reminder, the office will need **CURRENT** copies of your State registration, Insurance Policy that shows watercraft liability, and Boaters Safety Class record. If you renewed either of these since your previous registration with the office last year, please make sure to forward a copy to the office. Should you wish to verify if we have current information, please call the office. You must have paid the first half of 2017 assessments to acquire either decal.

The price to lease a boat slip for 2017 is \$150.00. If you are interested in renting one, please contact the office @ 540-967-1408.

#### **Compliance Committee Report**

**Septic System Inspection** 

All members are required to have standard septic systems inspected every five years by a certified septic company. Alternative pumping systems must be inspected and or pumped every year. Please submit your certification to the office. This is not only a BRS requirement but a requirement from the Commonwealth of Virginia enforced by all county health departments. The BRS office notifies each member at the beginning of the year when your system is due for inspection. You have until December 31 to comply. Members that do not comply may be fined \$10 per day for 90 days. Our Committee recently took this action on three members and this information may be posted in the Shore Line by name and Street Address. There are no exceptions. This rule is to ensure the health of our lake and the health of our water supply. Thank you for keeping Blue Ridge Shores a healthy community for all.

#### **POSTED SPEED LIMITS**

The Association Office receives complaints routinely for people driving throughout the Community and exceeding the posted speed limits. The Louisa County Sheriff's Department has been most helpful in their attempts to resolve this problem. They have jurisdiction to write summons for speeding or reckless driving on Association Roads and the results go into Louisa County General District Court and if found guilty those results will be posted with DMV and appear on your Virginia Driver's License Records.

The Sheriff's Department has assured us of enhanced efforts to resolve these problems and will be placing Deputies in the areas of complaint. Please be considerate of yourself and others as it relates to the potential consequences of traveling too fast within the Community.

The Thomas Jefferson Soil & Water Conservation District is currently offering



The 2017 Dredging Project on the Lake will begin in a few days and is scheduled to be completed within 45 days with weather cooperation. Work in the upper Hickory Creek Channels is complete and there will be work in several of the coves. This will involve some relocating of boats for a few days and we will notify you ASAP on that issue. The project is designed to create "little to no" disruption of lake enjoyment, with no work on the weekends or holidays. The contractor, **Docks of the Bay** is accustomed to working in populated areas and will conduct their operations with courtesy and respect of the membership! Please contact me with any concerns or questions you may have!

I urge those that wish to sign up for a partial payment agreement in order to avoid higher monthly payments to do that immediately. To date we have approved twenty-five. We have collected 88 % of the 2017 revenue affiliated with assessments and rental fees by the end of June, 2017. A MNIGS Hearing has been established for August 12, 2017. Our delinquency rate for 2016 was 2.2%.

Remember nothing can be placed in the Lake including leaves without Board permission.

Please look at your 911 address for your property and be sure it is accurate and per the regulations. The 911 address as assigned by the County must be displayed in three inch numbers, clearly visibly from the street. That address/number must be displayed on the side of the street that the house is located and be adjacent to the entryway/access to your house from the street. This is very crucial when seconds count in having emergency personnel responding to your needs.


Ridge Utilities is very pleased to announce that all wells are in excellent condition for water supply and all required testing to date has been completed with a 100% passing of those requirements. The 2016 Water Quality Report was distributed early and if you did not receive that, extra copies are in the office.

Water Quality Testing of the Lake was completed recently and all samples were within allowable standards. This occurs monthly from May through September and dredging in the upper channels has improved the 2017 results in comparison to 2016.

Please remember when you are on the lake enjoying boating to maintain a safe distance of 100 feet off the Shoreline and if you are pulling floats or tubes, you need to have that spotter. Failure to do that could result in the Compliance Committee suspending your recreational privileges for a period of time. Please respect members' docks, boathouses, and seawalls by maintaining that distance away.

I will be conducting a Shoreline Inspection including docks, piers, and boathouses in the near future.

Should you witness any activity that appears unlawful; contact the Sheriff's Department immediately and also make the office aware of the issue including tag numbers, type of vehicle, and if by chance you know the individual(s). Your identity will not be disclosed by them. If you experience an event that is not neighborhood friendly, please contact the Sheriff's Office immediately. This also includes stray dogs. The Sheriff's Department is currently assisting by monitoring the speed of vehicles on the roadways. Their non-emergency # is 967-1234.
