My name is Roger Payne. I am a resident of Walkertown, 5207 York Place Court in Whitehall Village. 140 units have been sold bringing several 100 cars to Whitehall. My question, is there a law keeping the gate to Ruxton Road closed?
Doc: Yes, by Town Ordinance. The old middle school was on Ruxton. The school and the residents on Ruxton and Lakawanna asked for the gate to remain closed. They were concerned about traffic from 66. Would you like the gate opened?
Roger: Yes. Describes morning and evening rush hour traffic. Discussion on DOT plans for 66 . We want to do the right thing. We could get a signed petition. Maybe open the gate temporarily to see how it effects traffic. I don't expect much cut through traffic. What do we do?
Doc: I don't think Keystone wants the gate open. We'll take under advisement. You don't need a petition, we're much too informal for that.
Scott: I would be glad to come speak with your HOA.
Roger: Thank you Scott and thanks to the town for snow removal. You did a great job. I don't think Keystone would have done anything.
Peggy: I think an Ordinance would come back to the Town Council and maybe the

Planning Board for consideration.

Doc: We'll get quotes for the vinyl work. Any other questions from the council? No. Then we need a motion.

Doc: The let date for the widening US 66 is $2 / 15 / 2022$ and ROW acquisition to start on 2/21/2020.

## 3. FINANCIAL STATEMENTS

Doc: We haven't completed our seventh month of the year yet, which puts us at $\sim 58 \%$. Property tax is a little behind at $51 \%$.
Sales tax has caught up and in at 61\%. Most departments are under.
Revenue "in" at 60\%. Expenditures "out" is at $43 \%$.
Fire Department costs at $73 \%$ are ahead because we have already made our
$3^{\text {rd }}$ quarter payment.
Unrestricted Funds @ \$3,471,922.30 and Restricted Funds @ \$1,068,722.28 for a Grand Total Fund Balance of $\$ 4,540,644.58$.
