Sunday is the Amana Chautauqua Show

Bring your lawn chairs and wear your masks, it's the first ever Amana Chautauqua Sunday, September 6 at the Market barn in the village of Amana. The entertainment starts at 6 p.m. with the lowa Riverbottom Ramblers playing bluegrass music.

Then get set to see "Miliken's Bend" a 40 minute dramatic reading of a play about a Civil War battle. Two soldiers share their memories of the battle telling their story from their own perspective. Starring Rob Merritt and Anthony Hendricks, this a reading of a script created by Cynthia Mercati and the Emmy Award winning Des Moines native, Greg Alan Williams, about a singular battle during the Vicksburg campaign. Also look forward to dramatic readings by Meg Merckens and Quanda C. Hood.

To top it all off there will be slices of Ox Yoke Inn pie for sale starting at 6 p.m.

There is no admission fee – but goodwill donations will be accepted by the producers Tom Milligan and Deb Kennedy on behalf of the actors and stage crew. Yes, the show will feature a professional sound system so you should be able to hear it from your socially distanced lawn chair.

Oktoberfest 2020 is Cancelled

Yes, it's true. A press release issued August 31 by the Amana Colonies Convention and Visitors Bureau states that the popular Oct. 2-4 event has been cancelled due to COVID-19 concerns and the pandemic response in lowa.

With the number of new cases in Iowa as reported by the state's COVID-19 response team coupled with Governor Kim Reynold's August 27 proclamation closing bars, pubs, breweries and wineries in 6 counties, those who organize Oktoberfest met to discuss its future last week. The decision was reached to cancel Oktoberfest 2020. Oktoberfest is Amana's largest visitor event drawings more than 15,000 in good weather.

The ACCVB and the Main Street Merchants plan to replace the fall festival with a series of themed weekend promotions. The themed promotions called "Autumn in the Amanas" are to begin in mid-September and continue through the first week of November. These promotions will focus on creative ideas for Amana fun, retail shopping or dining opportunities, activities that can be done out of doors at multiple venues or indoors in very small groups or/and reservation-only events, in other words, activities that don't draw a large crowd to gather in one place. The ACCVB is currently asking its members to think of safe activities to help make these weekend promotions worthwhile for visitors.

Rumors about the fate of Oktoberfest have been swirling for weeks as residents and merchants wondered. The cancellation of the Iowa State Fair and the Big 10 Football season, sparked further talk here. Ongoing discussions as the pandemic unfurled this summer led the board of the Amana Main Street festivals committee, which hosts and organizes Maifest, Oktoberfest, Prelude to Christmas, Winterfest and Wurst Festival Amana, to meet last week and make the call

Their discussion, Main street festivals coordinator Elise Heitman said, led to this decision. She noted that while they felt they had a good plan for making the event in the Festhalle safer, it would be difficult if not impossible, to control crowd size, social distancing and mask wearing on Amana's streets. Keeping everyone safe is the number one priority, therefore the group cancelled Oktoberfest. Heitman said that this week she would begin contacting food vendors, bands and others who provide goods and services under contract to Oktoberfest.

Scam Alerts for These Times

"Three guys in a pickup truck stopped in my yard and said they were 'volunteers.' They sawed down and loaded up a fallen apple tree by my porch. Then they demanded \$500 to haul it away! I said, 'Oh no! I don't have \$500 to spare them.' So there was some yelling back and forth and finally they dumped it right in my front lawn." "I had heavy tree damage in my yard . . . this one company, they said they were from Benton County, but it turns out it was an outfit out of Missouri, they pulled in and offered to clean it up for \$8,000. I wrote them a check for half and paid the other half in cash. Then half way through they said it would cost another \$10,000. Now what?" said one homeowner from Cedar Rapids.

Tom Miller, lowa Attorney General, issued a "price gouging and storm aftermath scam" alert this week following the August 10 storm that swept through central lowa leaving a huge amount of damage in its wake.

This disaster has triggered lowa's "price gouging rule," which forbids excessive prices for goods or serviced "needed by victims of disaster." That includes but is not limited to water, food, medicines, sanitation supplies, utilities and building materials. This also applies to services for tree removal, general clean up and repairs. It even includes goods and services purchased via Craigslist, Facebook and other online marketplaces. Punishment can result in restitution and fines.

The Iowa Attorney General's office publishes a newsletter which you can subscribe too by going to the Iowa Attorney General's s website and look for the title on the right hand side of the home page to sign up for "Consumer Focus Monthly Newsletter." In a recent issue the office advised:

- Formal complaints are up 28 percent this year for home improvement problems.
- If a home-improvement contractor, roofer or tree service company stops by and says, "I was just in your neighborhood and saw you need work done. "Be wary. Legitimate contractors have enough work to do. They don't just drive up looking for work.
- If they say things like, "Hey my guys need one more job to help them make their pay day quota, " or "I have leftover materials I gotta use." Don't believe them. They are trying to win you over.
- If they say, "I can give you a discount but you need to sign this today." If they pressure you to make a decision today. Be very wary. Legitimate contracts should understand that you need to follow up by checking their references. Plus they know you have to work with your insurance company.
- Never sign an "agreement" or contract on impulse. Always ask for and check references.
- Only agree to use a worker or contract you know, or you can easily check. Make some phone calls and check them out with neighbors, friends, family. See if they advertise locally. Call your insurance agent to see if they know the company or owner.
- Go online and google their name. See what comes up.
- Always get two or three bids for any work. Make sure the contractor takes the time to look at your job and see everything that needs to be done. Make sure you agree to a plan for "unforeseen" issues. As in, they don't do any additional work until you see and approve.
- Get all bids, guarantees and promises in writing. Agree in advance to start and completion dates.
- Asking for payment upfront is a red flag. Legitimate contractors have lines of credit with local suppliers. Asking you to pay upfront is not a good sign. Do NOT pay a large upfront payment. Before agreeing to the work always talk about payment with the contractor and agree in advance, in writing to how much will be paid and when. Be wary of anyone who wants a large amount before job start.
- If someone makes you feel fearful or threatened, ask them to leave. If they don't call 911. Do not hesitate to call for help if anyone makes you feel threatened.

When are volunteers not volunteers? When they demand payment. If someone says they are a volunteer there to "help you with your trees" or whatever, feel free to ask them if they expect payment. Then ask them for their identification and to identify the church, charity or group they are affiliated with. If they get angry or are uncomfortable with your questions, ask them to leave. If they say they are "on their own" and not associated with a church or charity, ask them to provide the names of others in the area they have helped. Take photos of them, their vehicles and license plates. If they are uncomfortable with that, ask them to leave. Call 911 if anyone makes you feel fearful or threatened.

Report any suspected scams or suspicious situations to your local law enforcement and to the Attorney General's office. Call the Iowa Attorney General's consumer protection division at 515-281-5926 or email go to iowaattorneygeneral.gov for more information.
