A few words about California State Sales Tax laws. All dealers must comply with state laws and apply for a temporary Seller's Permit unless you already have a California Seller's Permit. It's not hard to do. Simply fill out and submit a "BT-410-D Swap Meets, Flea Markets, Or Special Events Certification" form to the California Board of Equalization (see address below). On that form please note "Section 3. STATUS." If you already hold a California State Board of Equalization Seller's Permit, check that box and enter your account number in the space provided. If you don't have a Seller's Permit, and aren't selling either Exempt Property or your sales aren't exempt Occasional Sales, then you must fill out the Temporary Seller's Permit. After the convention, you may be required to file a Sales Tax Return with appropriate attached forms. Box 942879 Sacramento, CA 94279-0001 (916) 255-3350 You do not need to submit your seller's permit with this application, but you should have the permit available during operating hours at the convention.

GENERAL TERMS AND CONDITIONS FOR EXHIBITORS AT OZCON INTERNATIONAL 2019.

1. Acceptance, Payment, and Table Reservation

By signing and submitting the OZCON INTERNATIONAL Exhibitor Application form, Exhibitor agrees to abide by all terms and conditions stated herein should Exhibitor's application to exhibit at OZCON INTERNATIONAL be accepted by OZCON INTERNATIONAL. Once accepted, requested table(s) and membership(s) will be reserved for Exhibitor for a period of up to two weeks or start of OZCON INTERNATIONAL Dates, whichever comes sooner, pending receipt of payment in full. Should payment from Exhibitor not be received within the stated period, requested table(s) and membership(s) will no longer be reserved.

2. Qualifications of Exhibitor

OZCON INTERNATIONAL, in its sole discretion, shall have the right to determine whether a prospective exhibitor is eligible to participate in OZCON INTERNATIONAL. OZCON INTERNATIONAL reserves the right to restrict or remove any exhibit—including but not limited to items displayed or for sale—which OZCON INTERNATIONAL, in its sole discretion, believes to be objectionable.

3. Assumption of Risks, Releases, and Limitation of Liability

Exhibitor assumes all risks associated with, resulting from, or arising in connection with Exhibitor's participation, travel to and from, or presence at OZCON INTERNATIONAL. Exhibitor should in particular be aware that it assumes sole responsibility for its property, including any theft, damage or other loss to such property. OZCON INTERNATIONAL shall under no circumstances be liable for any loss or damage experienced by Exhibitor. OZCON INTERNATIONAL makes no representations or warranties, express or implied, regarding the number of persons who will attend OZCON INTERNATIONAL guests that will appear, or regarding any other matters.

4. Assignment and Occupancy of Space

Exhibit space at OZCON INTERNATIONAL shall be assigned by OZCON INTERNATIONAL in its sole discretion. OZCON INTERNATIONAL reserves the right to change the floor plan or to move an Exhibitor to another location prior to or during Con. OZCON INTERNATIONAL shall, at its sole discretion, specify dates and times for installing, occupying, and dismantling exhibits. If Exhibitor fails to install its display in its assigned space by one hour before the Exhibitor area opens or leaves its space unattended during the Exhibit hours, OZCON INTERNATIONAL shall have the right to take possession of the space and any refund of amounts paid by Exhibitor to OZCON INTERNATIONAL pursuant to this agreement will be at the sole discretion of OZCON INTERNATIONAL. All exhibits must be open for business during all Exhibit hours unless permission is explicitly granted by OZCON INTERNATIONAL. Exhibitors may not allow any other persons or legal entities to use their assigned display space in whole or in part without prior approval by OZCON INTERNATIONAL. Exhibitor shall limit its activities at OZCON INTERNATIONAL to its assigned exhibition area unless it receives explicit permission to do otherwise from an authorized OZCON INTERNATIONAL representative.

5. Use of Sound

The use or production of sound by Exhibitor must be such as will not interfere with the activities of other Exhibitors or be disturbing to attendees. The determination and evaluation of such matters is at the sole discretion of OZCON

INTERNATIONAL.

6. Displaying, playing, or selling materials that may be deemed obscene or otherwise offensive

OZCON INTERNATIONAL, at its sole discretion, shall have the right to restrict the display, playing, or sale of any materials of any nature or media that may be deemed obscene or otherwise offensive. In particular, this applies to, but is not limited to, what are commonly known as “adult” materials. No “adult” materials may be displayed or sold without prior permission of OZCON INTERNATIONAL. If such materials are allowed to be displayed or sold, Exhibitor nonetheless must take reasonable steps, as determined at the sole discretion of OZCON INTERNATIONAL, to ensure that minors are not allowed to view or purchase “adult” materials.

7. Listings and Recordings

By entering into this contract, Exhibitor expressly grants to OZCON INTERNATIONAL a fully paid, perpetual non-exclusive license to list Exhibitor as a OZCON INTERNATIONAL participant. However, OZCON INTERNATIONAL shall not be liable for any errors in such listing and makes no warranty that any such listing will occur. Exhibitor agrees that OZCON INTERNATIONAL may also record images and sound, using any technology, of Exhibitor's exhibit space, exhibit, and personnel at OZCON INTERNATIONAL and use such recordings for any OZCON INTERNATIONAL promotional or informational purpose.

8. Cancellation by Exhibitor

Exhibitors that cancel their participation in OZCON INTERNATIONAL for any reason up to 60 days prior to the opening day of OZCON INTERNATIONAL will be refunded any amounts paid to OZCON INTERNATIONAL pursuant to this agreement less a \$20.00 cancellation fee. Exhibitors that cancel their participation in OZCON INTERNATIONAL less than 60 days prior to the opening day of OZCON INTERNATIONAL may request a refund, but any such refund and the amount of any such refund will be at the sole discretion of OZCON INTERNATIONAL.

9. Cancellation by OZCON INTERNATIONAL

If Exhibitor fails to abide in whole or part by the terms of this agreement, OZCON INTERNATIONAL may, at its sole discretion, cancel Exhibitor's participation in OZCON INTERNATIONAL. If cancellation of Exhibitor's participation in OZCON INTERNATIONAL occurs 60 days or more before beginning of OZCON INTERNATIONAL dates, any amounts paid by Exhibitor to OZCON INTERNATIONAL pursuant to this agreement will be refunded less a \$20.00 cancellation fee. If cancellation of Exhibitor's participation in OZCON INTERNATIONAL occurs less than 60 days prior to beginning of OZCON INTERNATIONAL Dates, Exhibitor may request a refund but any such refund and the amount of any such refund will be at the sole discretion of OZCON INTERNATIONAL. Further, OZCON INTERNATIONAL may at any time cancel OZCON INTERNATIONAL at OZCON INTERNATIONAL's sole discretion. In the event of such cancellation, all amounts paid by Exhibitor to OZCON INTERNATIONAL will be refunded, such amounts constituting OZCON INTERNATIONAL entire liability to Exhibitor should OZCON INTERNATIONAL cancel OZCON INTERNATIONAL.

10. Compliance with federal, state, and local laws, regulations, and requirements

Exhibitor shall comply with all federal, state, and local laws, regulations, and requirements applicable to its participation at OZCON INTERNATIONAL. Said compliance and costs of compliance are the sole responsibility of Exhibitor. Said compliance includes but is not limited to the obtaining of licenses, permits, and approvals and the

payment of taxes, fees, charges, levies, fines, or penalties

11. Seller's Permit and BOE-410-D Certification

Exhibitor must comply with state law regarding the collection of appropriate sales tax and exhibitor must have completed a BOE-410-D Swap Meet, Flea Market, or Special Events Certification form. Any fines or penalties resulting from failure to have a complete and valid BOE-410-D form and Seller's Permit are the full responsibility of Exhibitor and any such fines or penalties assessed against OZCON INTERNATIONAL for this reason will be passed on to Exhibitor who agrees to accept responsibility for them.

12. Incorporation of Rules and Regulations

Any and all matters pertaining to OZCON INTERNATIONAL, whether or not covered in the terms and conditions of this contract, are subject to determination by OZCON INTERNATIONAL at its sole discretion. OZCON INTERNATIONAL may adopt rules or regulations at any time governing such matters and may amend or revoke them at any time, upon reasonable notice to Exhibitor. Any such rules and regulations (whether or not included in an Exhibitor Guide or any other OZCON INTERNATIONAL document relating to OZCON INTERNATIONAL) are an integral part of this contract and are incorporated herein by reference and shall have the full force and effect as if such rules and regulations are fully set forth herein. This contract (including any additional rules or regulations adopted by OZCON INTERNATIONAL at any time) states the entire agreement of the parties with respect to the subject matter hereof.

13. Governing Law and Costs of Enforcement

This contract is governed by the laws of the State of California as applied to contracts entered into and entirely performed within such state. Exhibitor agrees that the courts located in the State of California shall constitute the exclusive forum for the resolution of any and all disputes arising out of, connected with, or related to this contract or the breach of any provision of this contract. In the event legal action is filed by OZCON INTERNATIONAL to enforce the terms and provisions of this contract, the prevailing party in such action shall be entitled to reimbursement of court costs and reasonable legal fees.

You hereby agree that all information containing terms and conditions provided to you by OZCON INTERNATIONAL shall be deemed fully read and understood by you and that you shall be bound by all the terms and conditions contained herein and therein.
