VERDE VALLEY FAIR

Payments are accepted online or can be made by cash or check when you submit your items.

Youth – Ages 3 through 12 – on or before Jan. 1, 2018

Teen – Ages 13 through 18 – on or before Jan. 1, 2018

Adult – Ages 19 and up – on or before Jan. 1, 2018

Premium Award Entries – where applicable – All Ages

Youth, teen and adult divisions receive ribbon and monetary prizes as follows:

Best of Show: \$10.00, Blue Ribbon: \$3.00, Red Ribbon: \$2.00, White Ribbon: \$1.00

Premium Award Entries (Fine Art and Photography only) receive monetary awards which are determined by the number of paid entries in each division. See Fine Art and Photography requirements for more information.

All Departments EXCEPT:

Culinary Arts, Floriculture/Horticulture, Fine Arts and Photography

Entry Fee: \$1.00 Per Item

Paper Deadline: Friday, April 6, 2018 4:00pm (Fair Office)

Online Deadline: Monday, April 16, 2018

Receiving: Friday, April 20, 12noon – 7:00pm
Saturday, April 21, 10:00am – 6:00pm

Release: Monday, May 7, 9:00am – 1:00pm – Commercial Building & Tuesday, May 8, 1:00pm – 4:00pm – Fair Office, or call to make arrangements. **NO ITEMS WILL BE RELEASED PRIOR TO MONDAY, MAY 7 AT 9:00AM.**

- Exhibits must be the sole work of the exhibitor except where noted.
- There will be a \$1.00 fee per entered item. Premium entries in Fine Art and Photography will be charged a \$10.00 fee per item. Entry fees can be paid online at the time of registration or can be paid by cash or check when you bring your items to the fair. (see receiving dates above). Make checks or money orders payable to Verde Valley Fair Association. Entry fees are not refundable.
- All applications for entry must be complete. Should you need assistance with the online process, or have questions, staff will be available to help you. Contact the Fair Office at 928-634-3290.
- Completed forms, fees and entries must be received by the deadline as stated above.
- The Fair reserves the right to refuse entries or prohibit the exhibition of any article, for any reason whatsoever.

- Fair Management is not responsible for finding errors in entries. Exhibits which have been incorrectly entered may, at the discretion of the superintendent of the department, be transferred to their proper class before judging.
- Superintendents will make all assignments for space for the exhibits and will arrange the exhibits.
- Each exhibitor may exhibit a maximum of two items in each class. Additional identical or similar items **may not** be entered in classes listed as "other – please describe". (Floriculture entries please see Floriculture requirements).
- Classes may be combined where closely related at the Superintendent and Judge's discretion, providing an insufficient number of entries in any one lot does not provide adequate competition.
- Judging will be done prior to the opening of the Fair. Judging will not be open to the public or exhibitors.
- It shall be at the sole discretion of the Judge(s) whether the exhibits are awarded blue, red or white ribbons and corresponding premium money. If any entries are judged not worthy of a premium, the Judge(s) are instructed to not make an award. Judges decisions are final.
- Awards will be paid as follows to the exhibitor named on the entry form:
Best of Show will receive a Best of Show ribbon and \$10.00, 1st place will receive a Blue Ribbon and \$3.00, 2nd place will receive a Red Ribbon and \$2.00, 3rd place will receive a White Ribbon and \$1.00.
- Visitors will be asked to vote for a People's Choice. One People's Choice will be awarded from all exhibits. Winner will receive a ribbon and \$50.00
- The General Rules and Regulations of the Verde Valley Fair will govern exhibition entries.
- All exhibitors will be under the control and direction of the Fair Management, but Verde Valley Fair Association, Inc. its officers, directors, agents or employees will in no case be responsible for any loss, injury or damage that may occur. Each exhibitor will be solely responsible for any loss, injury or damage that may occur to him, his officers, agents, employees or exhibits during the Fair. The exhibitor shall indemnify the Fair against any and all legal proceedings in regard to the above and against damage or injury to any other person or property, caused by the exhibitor, his officers, agents, employees or animals.
- The Verde Valley Fair Association, Inc. reserves the right to use any and all photographs and or video taken during the Fair for publicity purposes.
- All Items may be offered for sale with pricing set by the exhibitor.
