Action Items: Rick talk to John Eaton Try Skype (is there a limit?) Appear.in as a fallback Next meeting: Tuesday 7:30

Finances: Rick collected laptop from David Phippen... needed power supply & password. Reactivated anti-virus. Last recorded transaction in mid-July. Asking if John Eaton can do the forensic work to bring us up to date. Current club sign-ups are still in the PayPal account.

Balance \$7500 is what is currently in Wells & PayPal account.

According to Dudley only 20 have paid their dues.

Motion passed unanimously to have John Eaton to take the books up to 2017.

Going to try moving to Skype for the next meeting. \$350 for 50-member go-to-meeting

We will need to start budget planning before the books are up to date. In 2016 there was a \$5000 double-hit for concessionaire's agreement. (July 1st 2017 an annual payment of \$2500 will be due.)

Move the Soaring Challenge from 3rd Weekend in June to July to reduce no-seeums? Bigger issue is the wind. Need to announce by March. Bugs or Heat. Tabled for now.

Budget question 2-day F5j?

Concessionaire event allows 2 2-Day events each year.

Discussion tabled as Scott M. checks with Chris on commitment and revenue potential.

Recap of meeting last week focusing on divvying of responsibilities taken on by Dudley. Need to move these to others. Primarily competition, accounting & secretarial roles. Other items could wait for a second round of transitions.

Should we change the newsletter role to something else? Change to SVSS Communications Officer. Distribution lists, business list, RCGroups Forum, & Newsletter. Website, scores, Posting of Calendar. Role expanding.

Rick will take over the database (membership, etc.)

Food services.... Are there alternatives? Subway pre-order? No action item, just starting the conversation.
