The Planning Grant of \$17,060 will be used for major activities: Develop the COC, Monitor projects to help build capacity of new HUD awardees, while ensuring compliance & desired outcomes, etc.; Coordinate activities of the homeless provider community, including but not limited to, PIT count, homeless outreach, CoC committee work in their respective focus areas); Project evaluation, COC application support

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

The planning grant will be put to work immediately, since the private funds already invested have allowed COC planning, expansion, compliance activities to be in process. The Collaborative Applicant, Catholic Charities as the fiscal conduit, will use its highly qualified internal Business Office to manage the grant funds effectively and efficiently. The Governance Board will direct planning dollars as listed in the Budget, part 4B of this application. The grant will be expended within 12 months of award.

3. How will the requested funds improve the CoC's ability to evaluate the outcome of CoC and ESG projects?

The CoC has recent investments by 2 private foundations to further the work of the CoC and bring Imperial County region into full HUD and ESG compliance, the HUD Planning Grant provides the seed money to do the initial evaluation process, that can then be carried on with the additional funds other private sources. The commitment of funding and increased CoC membership has given new impetus and enthusiasm to evaluate and improve outcomes throughout the system. The Executive Board of the COC is 'catching up' and is fully committed to evaluating projects, ensuring compliance with ESG and HUD mandates, expanding the funding to the most critical need populations.

4. How will the planning activities continue beyond the expiration of HUD financial assistance?

All functions of CoC are building, evolving. In 2016 & 2017, the community has made great strides in expanding the CoC, taping into all the agencies and groups dealing with homeless that have not previously worked together. The Resource Committee is committed to finding additional support for CoC work to aggressively address homelessness in the region. The addition of the business community to CoC has brought new energy to the aforementioned committees with a deeper commitment to find resource to continue the work to move

homeless people into homes and provide support services.
