## City of New Munich September 3<sup>rd</sup>, 2019

The City Council of the City of New Munich met in regular session at 6:30 p.m. in the City Hall. Jim Poepping, Shawn Duevel, Ron Doll, Elmer Boecker and Pat Nathe were present.

On a motion by Ron Doll, seconded by Shawn Duevel and carried the minutes from August 2019 were approved. Motion carried.

Allen Fielder was present to inform the Council of 2 medical call for the past month. All mentioned the MBFTE- MN Board of Fire Training and Education reimbursement amount for 2020 will be \$1,512.00 which can be used to reimbursement trainings for the Fire Department. All will be applying for a Gear Washer/Dryer Grant through the State Fire Marshall. He also mentioned Fire Fighting 1 classes will be starting soon and he has 1-2 guys interested in attending.

Tom Valerius, Water/Waste Water Operator noted the tower cleaning/maintenance was done by H & H Contracting. Lead and copper sampling were done at 5 different residents in town, we are waiting on the results. MN Rural Water came out to repair a valve and the south pond is shut off and will be ready for discharge in October. Tom presented 1 receipt for shipping water samples for \$9.00.

Karen Voz from MN Dept of Health, Drinking Water Protection and Katie Breth from Stearns County Water Shed/MN Rural Water attended the council meeting and briefly discussed the Wellhead Protection Plan, Tom Valerius was appointed the Wellhead Protection Manager for the City of New Munich, on a motion by Pat Nathe, seconded by Shawn Duevel. Motion carried.

On a motion by Pat Nathe, seconded by Elmer Boecker and carried the building permit for Ryan Venske and extension for Roger Boecker were approved. Motion carried.

We received estimates from H & H Contracting Inc for epoxy liner \$35,000-\$40,000 and a polyuea liner \$60,000-65,000, council is going to table until next year.

On a motion by Pat Nathe, seconded by Shawn Duevel and carried Resolution 9-19-A (Budget) was approved. Motion carried.

Leaf and grass pick up will be October 26th, leave bags open at end of driveways.

A resident had some issues with plugging up her home water lines when we ran the pigs through the lines in July, the City agreed to pay for her plumbing bill to fix the issue.

City is asking a resident to purchase 50' x 138' of land to use for a development plan. Resident was at Council meeting and Council agreed to purchase the land for \$4,250. On a motion by Ron Doll, seconded by Pat Nathe the purchase amount was approved. Motion carried.
