Westmoreland City Council Special Meeting Minutes February 25, 2022

The Westmoreland City Council met for a special meeting on February 25, 2022 at the Community Center at 6:00 PM.

The purpose of the special meeting was to hold an interview for the city treasurer's position in executive session regarding non-elected personnel and to protect their privacy.

Governing Body members present: Mayor, Mark S. Jack; Councilmembers Jim Smith, Waide Purvis, Ashley Rice, John Coleman, and Bruce Meininger.

City Staff present: City Clerk, Vicki Zentner.

Others present: Amanda (Mandi) Reese, applicant.

There being a quorum present, Mayor Jack called the meeting to order at 6:00 PM.

Councilmember Purvis moved to enter an executive session for non-elected personnel interview with the Governing Body members present, City Clerk Zentner, and the applicant for 30 minutes. Councilmember Rice seconded the motion. The motion passed five (5) ayes to zero (0) nays.

Councilmember Purvis moved to exit the executive session at 6:30 PM. Councilmember Smith seconded the motion. The motion passed five (5) ayes to zero (0) nays.
