75th IAI EDUCATIONAL CONFERENCE REVIEW OF EVENTS

The annual Educational Conference of the IAI was held in Nashville, Tenn. July 29 through August 3rd at the Opryland Hotel. There were over 450 Identification and Crime Scene officers, technicians, and Vendors present during the weeklong event. A basic minimum of 40 hours of training was held for all attendees. With breakout sessions in specialized areas, it was possible that double that number of training hours could be had, if one could be in two or three places at once! For those of you who aren't aware of the international flavor of IAI educational conferences, officers in Fingerprint attended from Great Britain, Santo Domingo, Japan, and so on as well as from all 50 states. All presentations are in english so fluency in American english helped. We a number of officers from the Canadian RCMP present, and guest lecturers from other countries as well. No one could say they didn't learn a lot because of a want of available specialized professionals to hear and see as most presentors had both lectures with slides and overhead transparencies to explain, describe and answer questions about their procedures, discoveries, etc.

Rick Somers gave an explanation on methodology for making luminal and demonstrated its' usage in field operations to those attending.
