B Water report given by Rich Richardson

Water leak today, inside the old Pennysaver building, we were able to get inside and turn the water off, as the outside shutoff was paved over.

Phil Palmasano. Barb Stewart talked with him about our water tower and Rich is following up with more information.

Water tower committee meeting, we rent our well sites; Bill noted that we do have an easement which we may want to update.

Relator came in and met with Rich regarding the former water properties. Listing the two well sites at the higher site, keep the former chlorination site and talk with the owners of the land locked pieces.

Bill McGuire asked about what options we have the lake well ever-go dry should. One option would be to pump water from lake to above the wells. The old wells/springs are not a safe source, and would not be approved by the health department. The pumping from the lake would allow for natural filtration. We do need to be aware of cost/need for a new pump.

The village water system is tested twice a year and the report is available online; discussion about the status of water in the school, and other issues within the water system.

Meeting with Hunt Engineers about grant options, here on Tuesday. Grant due in April.

Contacting sites about placement of new tank; with a tank can expand by going up. Need to have doubled the current capacity. A larger tank would also allow for filling the tank on a night rate only. We also need to consider a generator for the pump building.
