Greetings, Great news, July 1, 2017 National Marine Corps League hired a Chief Operating Officer (COO) Robert J. Borka. Mr. Borka comes to the League with 30 years' experience in the business world and since 2014 served as Director of Operations, with the Young Marines. Mr. Borka is former Cryptologic Technician (2651)/SSO. Life member of Flint Michigan #155.

Effective August 1, 2017 all new members and renewals will be assessed the full amount for dues and will expire on August 31, 2018 (09-01-18) from September 1, 2017 on, all memberships will be due for renewal on September 1^{st.}

National has purchased a stand-alone server for use as a National Database for membership. The incoming National Commandant, Wendell Webb, and company have been giving training and a preview of the system to Division Vice Commandants and Department Paymasters, looking for problems and questions regarding system operation. Sr. Vice Commandant Webb, indicated the system will go online around October of 2017 with division start-up, the indication is the Midwest Division will be the first to implement the new system. I ask all Detachment Paymasters and Commandants to review their membership rosters for accuracy, completeness including names correctly spelled, address, phone number, membership number, EIN #, Secretary of State Incorporation number, contact information for your detachment and the amount of dues you collect. One question that remains to be answered is how dues will be paid. One thought is to leave it as it is currently. The paymaster may collect renewal dues from members during the last few months prior to renewal date sand sent in a check for the amount due to Department and National. This will eliminate the time a detachment would have to wait for National to refund the dues amount to department and the detachment. More when the final decision is made. Training will be given to all paymasters prior to implementation. The paymaster will have to have a computer and have a basic knowledge of how to use a spreadsheet. The information on the membership will be entered by the Paymaster. The member will be able to enter the date base and only change, phone number, address and email address. All other information will be the responsibility of the paymaster. All National forms will be available as a fill-in and send form.

Marine Corps History

11 July 1798: President John Adams approved "An Act for Establishing and Organizing a Marine Corps", and it became law. The following day, the President appointed William Ward Burrows the Major Commandant of the new Corps. In August, Major Burrows opened his headquarters in Philadelphia, at that time still the capital of the new nation.

26 June 1918: BGen James G. Harbord, the Commanding General of the 4th Marine Brigade, notified American Expeditionary Force Headquarters that Belleau Wood was "now U.S. Marine Corps entirely." After 20 days of combat, and at a cost of over 4,000 casualties, the 4th Brigade of Marines had proven its fighting heart. The grateful Commander of the French Sixth Army would soon decree that in all official correspondence, Belleau Wood would henceforth bear the name, "Bois de la Brigade de Marine." 26 July 1947: The National Security Act of 1947 became effective, reaffirming the status of the Marine Corps as a separate military service within the Department of the Navy. The Act Provided for Fleet Marine Forces, and confirmed the Corps' mission of seizing and defending advanced bases, as well as land operation incident to naval campaigns.
