## \*\*\* INFO \*\*\*

- 1 Fill out Consignment Form and return with paperwork and \$50 consignment fee per horse.
- 2 All Belgian Stud Colts that are to be sold as eligible to register must have a Registration Application completed and a signed transfer in possession of the sale committee before the colt enters the ring, or it will be sold as a grade colt.
- 3 There will be a mobile lab and vet at the sale so Coggins can be done when you arrive. However, we recommend that you arrive at the sale with a Canadian Export Paper (shown on following page) for each horse filled out by your vet. This will ensure that your horse is eligible for purchase by Canadian buyers.
- 4 All horses consigned to the auction need to be at the auction or need a vet slip stating reason for withdrawal! If you do not have a vet slip, there will be a \$100 no show charge!
- 5 Please send original papers with a signed transfer for all Registered horses.
- 6 If we have your original papers, a signed transfer, your consignment fee is paid and have a valid Coggins and Canadian Export paper, you have the option to receive SAME DAY PAYOUT!
