## New Business

1. Calendar for the remainder of the year

- Because our enrolment numbers for the 2020/21 school year only enable us to split for a portion of the year, we now have to make decisions about combining
the 2 classes.
- We've come up with 2 possibilities ways to finish off the year and wanted to present them tonight for the parents to vote on. These options take into account that COVID is still going and numbers are again rising. One of the options does incorporate some at-home learning. The classroom is small and combing the classroom would mean kids would be packed in pretty tight and cleaning would be decreased.

Option 1 - Because combining the classes will double the exposure chances for the students, we've come up with an option to keep classes separate until the end of the year. This option would include some at-home learning in May and June. After the 2nd week of May, there would be one in-class day for each class, and one at-home learning day. With this option, we would be able to have our EAs support for the at-home learning and it would be more structured then we were able to do last year, and there would be better support for the students.

Option 2 - Combining the classes. In talking with the board and the teaching staff we've come to realize that combining the classing suddenly would be extremely difficult at this time. The kids have done a great job dealing with this pandemic, but the pandemic has raised the social and emotional needs for many of the students. Some of them need more time to work on social skills and emotional regulation. The option would be to slowly and gradually combine the classes.

There was discussion around the 2 options and some of the parents asked for more time before they decide. The decision was made to have a meeting on Monday, March 29, 2021 to vote on option 1 or 2.
2. Last fundraiser

- discussion around which fundraiser we should do next - possibly LIttle Ceasar's Pizza kits, or gift cards to Sailbury Green Houses (both offer 20\% back).
- We will gather some more info and decide during the meeting on Monday.
