There being a quorum, Mayor Simmons called the meeting of the Vienna City Council to order at 6:36 p.m.

Alderman Myrick made a motion to approve the Omnibus Consent Agenda consisting of the July 5, 2018 City Council Meeting Minutes, the Warrant (\$22,339.10) and the June Treasurer's Report. Alderman Racey seconded the motion. Roll call: **Hill-absent, Riddle-yes, Myrick- yes, Owen-yes, Racey-yes, and Tuey- yes. Motion carried.**

NEW BUSINESS

Alderman Racey made a motion to Authorize and Approve the Zoning Board's decision to approve applicant, Albert Burgess's request for a Special Permit to place a double wide or modular home at the location of 403 South 3rd St. The motion was seconded by Alderman

Tuey. Roll call: **Hill-absent, Riddle-yes, Myrick- yes, Owen-yes, Racey-yes, and Tuey-yes.**
Motion carried.

Alderman Tuey made a motion to Authorize and Approve Ordinance 18-07, an Ordinance Amending Section 154.68 (Special Procedures and Permits of Chapter 154 (Zoning Code) of Title XV (Land Usage) of the Vienna Code of Ordinances. Motion seconded by Alderman Riddle. Roll call: **Hill-absent, Riddle-yes, Myrick- yes, Owen-yes, Racey-yes, and Tuey-yes.**
Motion carried.

PUBLIC COMMENT

Joe Fitzsimmons, President of the Illinois Forestry Association was present to request use of the City Park for Saturday, September 1, 2018 to hold a community event from 1:00 p.m. to 8:00 p.m. including free refreshments and various representatives providing information of the Shawnee National Forest. Council gave consent.

CITY ELECTED AND APPOINTED OFFICIALS

Mayor Simmons informed council that the city may seek a part time hire in the spring to assist with city park maintenance. Simmons also informed council of a meat vendor, 5 S Cattle Company that would be setting up in ROC One parking lot at the four way on Fridays from 8 a.m. to 11a.m. Simmons said this would help with the need of meat for local residents.

Clerk Wright informed council the FY Audit would begin on July 24th. Wright also mentioned the "Trunk or Treat" event put on by Shawnee Worship Center which would take place on Halloween evening at the City Park.

City Supt Racey discussed repairs needed to a pump station on 146 East. Racey also questioned city ordinances prohibiting propane tanks.

Chief Miller discussed citations for ordinance violations.

Fire Chief Williams reviewed monthly fire calls mentioning assistance given to Pittsburg, IL furniture store fire as Vienna department is part of MABAS (Mutual Aid). Williams said 27 departments from the region responded to the fire.

Phil Morris, Depot, updated council of depot happenings. Morris said he would be setting up at the Marion pavilion Friday, July 27th to promote Vienna and Johnson County.


