Supervisor Smith called the meeting to order at 6:15 pm followed by the Pledge of Allegiance.

Purpose of Public Hearing – to accept Local Law #4 of 2024 – "Tax Cap Override" for the 2025 Tax Year. Supervisor Smith stated that this DOES NOT mean that the Town will increase taxes over the limit, but it gives us the option (without penalty) if needed.

No public present, meeting left open. Supervisor Smith closed the public hearing at 6:30 pm. Supervisor Smith called the meeting to order at 6:30 pm followed by the Pledge of Allegiance.

Public Be Heard – no public present

Reports:

- Supervisor spent 3 hours today chasing water/sewer issues. The town is in good shape for now and the attorney is making headway, the ball is in the village's court now. Budget issues 30% increase in insurance and everyone can see that spending looks to be higher than last year. Clerk has been given the preliminary budget for 2025. There are issues with the new neighbor of the old town hall. Installed a cellular line at the Highway Dept and removed the land line which hasn't been used in years.
- b. Deputy Supervisor spoke to Jeremy Horton regarding signs for the parking lot and building. Attended the Council of Governments meeting where the Humane Society was discussed. There was no representation from the Humane Society and no numbers were given to support their requested increase. There is another meeting scheduled for the 26th.
- c. Bookkeeper none
- d. Superintendent of Highway Report oil and stones service treatment on Townsend Road, Pearl Street and Hedden Road; shared service with Montour 2 trucks, 1 day; Reading 2 trucks, 3 days; Hector 3 men, 2 trucks, 4 days; County tire day 1 truck, 1 man. Mowing road sides; service summer equipment so ready for next spring; Volvo 6 broke down – erg issues, exhaust, brake issues, ignition was smoking at the repair shop; hauled in some stone and gravel for stock pile. Weed whacked a 3-foot perimeter around the water towers.
- e. Code Officer 12 permits issued since last report, 3 building permits issued, 3 electrical permits issued, 1 heating permit, 1 sign permit, 2 tent permits, 2 firework permits, 1 violation issued (garbage), 1 fire call (tree fell on house). Total fees collected \$836.00. Beaver Dams Solar project is moving along slowly and a new retaining wall was put in at the Kingdom Hall to make an ADA compliant parking area.

Code Officer Tremblay reported that he has been looking into new software and found one that he thinks would work better than what we have now. The first year the cost would be \$5,500.00 and then \$3,500/year after. Currently the Town is paying \$2,000.00/year.

Motion offered by Gregory, seconded by Moore to enter executive session for litigation. Entered executive session at 7:31 pm.

Returned to regular session at 7:50 pm, there being no further business, Supervisor Smith adjourned the meeting at 7:50 pm.
