April 21, 2018

- Call to Order: Meeting was called to order by President Aaron Wade at 1:03 pm, followed by a brief welcome and the pledge of allegiance. Directors present: Bobby Abrahams, Jeff Eldred, Arland Jolly, Calvin Mennenga, Gene Putz, Rod Richardson and Paul Schaefer. Wayne Schoel was absent.
- Secretary's Report: Secretary Paul Schaefer read the minutes from the January 20th meeting, motion to approve by Bob Gihring, second by Steve Michael, motion approved.
- Treasurer's Report: Calvin Mennenga reported as of March 31, 2018, there was a beginning balance of \$17,200.28 Income: \$6.55 interest, \$500 donations, Membership \$2,305.00 with a total \$2,811.55 and balance of \$20,011.83.
- Newsletter and Website Report: Pam Olson reported the website has had 12,000 hits on it which is more than last year. Of the 651 names she has 434 email addresses, and there are 105 being sent by email only. August 1st, will be the next deadline. Brian also reported because of our 501c3 status we receive a sizable postage discount, around \$.28 per newsletter. Because of doing our newsletter in house we are saving our club considerable expense

Thanks to all from Chapter 5 who made it to the Branson Winter Convention It was an excellent show. RPRU 2018 in Alabama coming soon, hope to see many of you there Any donations go to the National Trust, principally for legal and protection reasons. The funds are distributed to what they were intended for. Jerry Mez recently retired from the committee, our Diane Caloud has filled that vacancy. Harvester Highlights videos can now be found on you-tube, there has been up to 40,000 hits to view it. Joe had mentioned the board is setting guidelines regarding insurance. If you are a paid member you are covered at IHCC sponsored events, other items such as renting golf carts or using your own cart or UTV you must have proof of personal insurance.
- **Merchandise Report:** Bobbie Hammer reported that there was \$802 of sales at Branson, and the total for this year is \$1,203.50.
