

City of New Munich
City Council Minutes

December 3rd, 2018

The City Council of the City of New Munich met in regular session at 6:30p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, Bryan Kasten and Ron Doll were present.

On a motion by Ron Doll, seconded by Bryan Kasten and carried the minutes from November 5th, 2018 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of two medical calls last month. Allen also submitted one bills that need to be paid Motorola \$3,749.25. He mentioned the Christmas timer needs to be replaced for the Christmas lights, ask Jesse LeClaire to switch out for new timer. Skating rink should be cleaned out, the fire dept would like to flood the rink soon. He also mentioned they have 2 new members starting this month. The fire relief had a meeting this month and the group made a motion to increase the retirement from \$750 to \$1,000, the council also made a motion, approved by Bryan Kasten, seconded by Shawn Duevel.

Waste/ Water Operator, Tom Valerius was present to inform the Council that the remote water disconnects that we were going to purchase is going to wait until first quarter, the company is going to make some changes on that model. Tom also spoke to a resident that had a over due water bill, they paid for half and were working on paying the rest soon. Tom will keep in contact with the resident. On the Waste Water side, Tom shut off the south ponds, all will be going to the north ponds over the winter. Pat Nathe looked into pricing on battery back up for the pumps and we are looking to replace 3-4 of them. Tom had 2 invoices that need to be paid, Spee Dee and a paint receipt.

Pat Nathe mentioned that he received a call from the County and they are looking to rebuild the road through town, as a City we need to look at replacing, sidewalks, hydrants, storm sewers and any updates that are needed to be done when the road is dug up. We need to start talking to residents about switching out their water lines. Jim will touch base with County to get all the details.

Pat Nathe asked the council to have a blanket easement removed on his property, a motion was made to approve by Bryan Kasten, seconded by Ron Doll a public hearing will be schedule for next month.

On a motion by Shawn Duevel, seconded by Ron Doll and carried the Resolutions 12-18-A, 12-18-B and 12-18-C were approved. These are the new policies for were requested by the auditors.

Salt request from residents some icy spots in town, Roger Boecker will take care of it.
