New Business:

General Obligation Bond Ordinance – Bond Council John R. McDevitt of Skinner Fawcett LLP presented a draft of the bond ordinance that is required in order for the District to call for a bond election.

Chairman Moyle moved to adopt Star Fire Protection District Ordinance 2019-01 and to direct the District Administrator to notify Ada and Canyon Counties of the Bond Election and to publish the Ordinance Summary in both the Idaho Statesman and the Idaho Press:

AN ORDINANCE CALLING A GENERAL OBLIGATION BOND ELECTION TO BE HELD FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF THE STAR FIRE PROTECTION DISTRICT, ADA AND CANYON COUNTIES, IDAHO, A PROPOSITION FOR THE ISSUANCE OF NEGOTIABLE GENERAL OBLIGATION BONDS OF THE DISTRICT; DETERMINING THAT THE TOTAL AMOUNT OF BONDED INDEBTEDNESS OF THE DISTRICT WILL NOT EXCEED TWO PERCENT (2%) OF MARKET VALUE OF TAXABLE PROPERTY; DIRECTING THE CLERK TO NOTIFY THE COUNTY CLERKS THAT THE BOARD OF COMMISSIONERS CALLED THE BOND ELECTION; APPROVING THE FORM OF NOTICE OF GENERAL OBLIGATION BOND ELECTION; APPROVING THE FORM OF BALLOT; PROVIDING FOR THE ISSUANCE OF SUCH BONDS AND MAKING PROVISIONS FOR THE PAYMENT OF PRINCIPAL AND INTEREST DUE ON SUCH BONDS; ORDERING PUBLICATION; PROVIDING FOR A WAIVER OF THE READING RULES; AND PROVIDING AN EFFECTIVE DATE.
