WAGS AND WHISKER'S PET RESCUE Volunteer Application and Agreement

VOLUNTEER AGREEMENT

Vaccination of Outside Pets: To protect outside pets from contracting any potential shelter diseases, and to prevent the shelter pets from developing illnesses from outside pets, I certify that all my personal pets or pets in a home that I frequent are, at a minimum, current on their rabies, distemper, bordetella, and parvo vaccinations. Advisory: You are strongly urged to have a current tetanus vaccination to protect yourself should you be cut, scratched or otherwise injured in such a way that tetanus infection could threaten your health. I have read this and have been advised. Initial:
In consideration of this opportunity to volunteer, I agree to the following terms and conditions, intending to be legally bound by them:

- 1. I will abide by the mission, rules, regulations, policies and programs of Wags and Whiskers Pet Rescue, hereinafter referred to as "WAGS AND WHISKER'S PET RESCUE", while I am a volunteer. I also agree to observe and follow all signs and instructions posted inside the shelter building of WAGS AND WHISKER'S PET RESCUE.
- 2. I agree to allow pictures of myself to be used, without compensation, for the purpose of the promotion and publicity related to WAGS AND WHISKER'S PET RESCUE and possibly posted on social media sites.
- 3. If I stop being a volunteer for WAGS AND WHISKER'S PET RESCUE for any reason, or upon the request of WAGS AND WHISKER'S PET RESCUE or its representatives at any time, I will promptly return all of WAGS AND WHISKER'S PET RESCUE's supplies, equipment, records, money and other items in good clean condition.
- 4. I understand that the activity of working with shelter animals is hazardous and involves contact with animals that may be unpredictable. As such, WAGS AND WHISKER'S PET RESCUE cannot be held liable for injuries or accidents that may occur as a result of working with the animals. I assume the risks of being bitten, scratched, injured or frightened by cats, kittens, dogs and puppies, and any infections or complications that may occur as a result, in connection with my volunteer work for WAGS AND WHISKER'S PET RESCUE. WAGS AND WHISKER'S PET RESCUE is not liable to me for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer activities for WAGS AND WHISKER'S PET RESCUE, unless they are the result of WAGS AND WHISKER'S PET RESCUE harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses whatsoever, sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for WAGS AND WHISKER'S PET RESCUE, or my breach of WAGS AND WHISKER'S PET RESCUE's rules, regulations, policies and programs.
- 5. I understand that I may be exposed to canine and/or feline illness and disease and that it is also possible that I could indirectly expose my own pets to such illness and disease.
- 6. I agree that if I see any dangerous situation at the shelter I will notify the WAGS AND WHISKER'S PET RESCUE's Shelter Manager in writing immediately.
- 7. I understand and agree that WAGS AND WHISKER'S PET RESCUE may refuse volunteer applications for any reason.
- 8. If I will be sheltering or providing foster care or boarding any of WAGS AND WHISKER'S PET RESCUE's animals, I agree to fill out and sign the separate Foster Application and Agreement.
- 9. I have accurately and truthfully completed this Volunteer Application and Agreement.
- 10. Any modification to this Agreement must be in writing and signed by both parties. This Agreement is binding upon WAGS AND WHISKER'S PET RESCUE's and my respective heirs, successors, assigns, executors and personal representatives.

PERMISSION & RELEASE OF LIABILITY FOR VOLUNTEERS UNDER THE AGE OF 18

- 3. I acknowledge that there are risks that the child(ren) could be bitten, scratched, injured or frightened by the dogs/puppies and/or cats/kittens and I/we assume such risks.
- 4. I understand and agree that the Shelter/ WAGS AND WHISKER'S PET RESCUE may refuse volunteer applications for any reason.
