

RSAI news to share at AEA Superintendents Meetings April 2024

Legislative Update: <u>HF 2612</u> AEA Reform/Teacher Pay/SSA was signed by the Governor on March 17. See the <u>March 22 RSAI Weekly Report</u> for a breakdown of each division and the requirements in the bill. Hopefully, districts have TSS numbers from DOM by April 2. We are amassing unanswered questions.

The most significant changes in the bill since its introduction in January as <u>SSB 3073</u> and <u>HSB 542</u> follow:

- Media and Educational Services: The bill keeps that \$68 million in place, flows 40% through to AEAs, and lets districts retain up to 60% this first year. Changes to 100% under school district control beginning July 1, 2025. Districts will work with AEAs for up to all of the district amount, or could use the funds for special education services or for any general fund purpose.
- **Special Educational Services:** No changes for July 1, 2024, requiring all special education funding going to AEAs. Allows districts to keep up to 10% in the year beginning July 1, 2025. Requires districts to work with AEAs for the 90% and requires the remaining 10% must be spent on special education services, which could be, but is not required to be, with AEAs. There are no changes to Early Access, Child Find, or IDEA federally-funded services.
- **Task Force:** Task Force of stakeholders and policymakers will review all AEA services, programs and processes and make recommendations and make recommendations by Dec. 31, 2024. Several parts of the bill are not effective until July 1, 2025, so the Task Force could recommend intervening changes. Expect continued learning about the services that AEAs provide and how school districts and AEA will work together moving forward.
- **DE Division of Special Education:** specifies 13 FTEs in the DE's Des Moines office and up to 40 staffed regionally, apportioned to AEAs by enrollment for compliance (less than half of original bill.)
- **Changes to AEA Staff:** Various versions required mandatory removal of some AEA staff. This final version does not. (However, reduced funding means fewer AEA staff is inevitable.)
- Minimum Teacher Pay Increase: HF 2612 phases in the Governor's teacher pay increase over two years but gets up to the \$96 million for teacher pay by FY 2026, which disproportionately provides funding for rural teachers. We do not see funding specifically included for resolving compaction of the salary schedule. Please send us your questions and we'll do our best to answer them or find out who can.
- School Funding: HF 2612 sets the SSA rate of per pupil increase of 2.5% for FY 2025.

Remaining Work for the Session:

- **The State Budget:** The legislature must pass the state budget. House budget targets released last Friday set the budget goal at \$8.955 Billion, Senate \$82 Billion lower, at \$8.872 Billion. The Governor's Recommendation was \$8.919 Billion. There is typically not much in appropriations bills impacting PK-12, but we are watching for the \$14 million for education support professionals (hourly staff) in either the education appropriations or standings appropriations bills.
- **Policy Bills:** the Governor's Literacy Bill and Charter Schools Bill, and others are on unfinished business calendars in the House and Senate. Watch you inbox for calls to action if we spot things that need some advocacy attention. We are continuing to talk about teacher shortage and possible solutions.
