***If the '1 session' option is selected (Group or Individual). This agreement is renewed automatically and valid for each session until cancelled in writing.**

Policies

1. Fees

- a. A deposit equal to amount of one training session is due prior to the start of any training session. The fee is **NON REFUNDABLE**, but is credited to the total cost of your program.
- b. The training programs that are provided are non-transferable.

2. Refunds

- a. Except as described in section 5, refunds will not be given for programs not completed.
- b. If at any time an individual is unable to complete a training program due to an injury sustained during actual training in an Elevated Sports Academy session, the remaining sessions will be held on account until the participant is able to complete his or her training. After six (6) months, the sessions will expire.

3. Scheduled Appointments

- a. Any participant failing to show for a scheduled training session will forfeit that session.
- b. Failure to cancel without a 24 hour notice will result in forfeiture of that session.
- c. Warm up is mandatory prior to each training session. Each participant must arrive 10 minutes before his/her session to insure proper warm up has been performed prior to training. If the participant is over 15 minutes late for the session, they will forfeit that session.

4. Termination of Contract

- a. Elevated Sports Academy reserves the right to terminate the Participation Agreement of any participant immediately, if he/she fails to comply with rules and regulations of Elevated Sports Academy, if he/she engages in other conduct that is detrimental to the health or safety of the staff, other participants, or if he/she fails to pay program fees or other amounts that are due to Elevated Sports Academy. ***Upon termination or cancellation of the participation agreement, the participant will remain liable for any other outstanding dues or other charges owed.***

5. Notice of Consumer Rights & Refund Policy

- a. You are entitled to a copy of this Agreement. You have the right to cancel the Agreement within three business days after receiving your copy. Notice of cancellation must be made in writing and delivered to Elevated Sports Academy by certified or registered mail to Elevated Sports Academy at P.O. Box 9382, Columbus, GA 31908.
- b. If Elevated Sports Academy is completely closed for one month or more due to fire, flood, weather, or other event that is out of the control of Elevated Sports Academy, Elevated Sports Academy will at it's option, either: 1) extend your program for a period equal to the period during which Elevated Sports Academy is closed, or 2) refund your program fees for that period (prorated refund). If Elevated Sports Academy is completely closed, due to the fault of Elevated Sports Academy you may receive a pro-rated refund of your program fees.
- c. In the event that the participant is permanently unable to exercise due to a medically documented condition, Elevated Sports Academy will require a signed letter from the participant's physician detailing the medical reason for cancellation of the Agreement. This documentation must be submitted to Elevated Sports Academy in writing by certified mail. Once certified, the Participation Agreement will be terminated as of the date Elevated Sports Academy receives valid documentation of permanent disability. You may receive a pro-rated refund of your program fees.

6. Entire Agreement

- a. You acknowledge that, except for what is contained in this Agreement, Elevated Sports Academy has not made any promises, representation or warranties to you. Only a written instrument signed by both the participant and an authorized representative of Elevated Sports Academy may amend this Agreement.

Terms and Conditions

1. **Commitment:** By purchasing Sessions, Client is making a commitment to his/her athletic career. Clients should follow the program and instructions of their Elevated Sports Academy to the best of their ability to maximize their results and better achieve their goals. Remember, the ultimate results are up to the Client: Elevated Sports Academy will show Client how to train his/hers muscles correctly and encourage him/her to go to their safe limit, but Client is the only one who can make sure he/she works out consistently, eats properly, gets plenty of sleep, and lives a healthy athletic lifestyle.
2. **Attire:** Client must wear comfortable workout attire, including, but not limited to, clean t-shirts, shorts, tights, sweats, and/or tracksuits. Athletic shoes must be supportive and functional.
3. **Stopping Exercises:** Client may refuse or stop any exercise for any reason. It is Client's responsibility to notify Elevated Sports Academy of any discomfort or pain arising from or during the training session, as well as, any and all other known limitations Client has or experiences so that Elevated Sports Academy may accommodate Client and substitute another exercise to work that particular muscle group.
4. **Option to Renew:** Upon contract renewal, Elevated Sports Academy will waive the initial assessment fee to which all new contracts are subject. By renewing a contract, Client acknowledges and agrees that Elevated Sports Academy acted professionally in all prior sessions.
5. If sessions remain after the time frame allotted (training schedule), both parties must agree to amend the training schedule in writing. Extensions may not exceed 30 days. If an extension is not agreed upon or is not adhered to, then the sessions will be forfeited and no refund will be awarded.
