

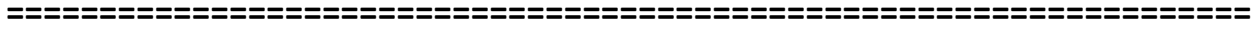


### 2019 Registration
