Opened Sealed bids for legal services for Town Attorney — Mayor Tony Junious opened the sealed bids for Town Attorney. The 1st bid was from The Smiley Firm, LLC, out of Columbia, SC. The 2nd bid was from The Carter Law Firm, LLC, out of Manning, SC. The 3rd bid was from Boykin & Davis, LLC, out of Columbia, SC. And the 4th and final bid was from Haynesworth, Sinkler & Boyd, out of Columbia, SC. It was stated that the bids would be discussed in Executive Session.

Mrs. Amanda Salka, Town Manager, informed Council that the Tisdale Pump Station will be replaced. She let Council know to expect a large bill from City of Manning for Sewer. The RIA Grant was discussed, as well as fixing the Side Cutter for the tractor. Also there will be a zoom meeting on June 7th, that will be attended by Mayor Tony Junious and Mrs. Amanda Salka with Blue Granite Water Company to discuss the Town's plans for the water systems.

Mayor Tony Junious spoke of several items during the mayor update. He mentioned that he spoke to Mr. Jim Clyburn about some grants for the town. It was said that the Town would find out in October or November if it was selected for the grant. Penny sales tax was discussed, as well addressing the needs of the water and sewer infrastructure. Plans for a Community Center and beautification of Exit 108 on I-95 were also discussed, as well as proposal for beautification for Summerton.
