Your membership in the Lakeview Property Owners Association (LPOA) is crucial to our entire community. Annual membership dues are used for the maintenance and upkeep of said community assets. Preserving and continuing to improve the lakes, parks, and common properties not only will have a desirable effect on everyone's ability to enjoy them, but also can contribute to increased property values throughout our community. Your membership is a great investment!

The 2018 LPOA memberships are available *only* to individuals owning property in the Million Dollar Lakes and Lake Retreat subdivisions. **DUES:** Annual dues are only **\$75.00** through **March 31**. Starting April 1, a \$15 late fee will be applied to all unpaid memberships. Payment via check is preferred (please make checks payable to LPOA). Membership applications and dues can be dropped off at the Lakeview Country Club, or mailed to: LPOA, PO Box 54, McCalla, Alabama 35111. Membership cards and boat decals will be issued but please keep your receipt as proof of payment until you receive your new cards and decals.

**LOCKS:** Beginning March 1, entry lock combinations to the lakes and common properties will be changed.

**LPOA MEMBER MEETINGS:** The four quarterly meetings are held at 7:30pm the second Tuesday of March, June, September, and December at the Lakeview Country Club. All LPOA members are welcome and encouraged to attend.

**LPOA GOALS FOR 2018:** The LPOA is looking to ramp up fundraising efforts to make major improvements in 2018. You can keep up with current and future projects by attending the quarterly meetings, and by visiting the "Community Projects" tab on MyLPOA.com.

**DONATIONS:** Fundraisers and donations for special interest projects by our members are encouraged, and help improve the quality and functionality of common areas. For example, previous donations to LPOA fisheries were used to improve the overall genetics of our fish population by releasing bass with clipped fins into the lakes (if these are caught, they must be released immediately). It is a goal of the LPOA to have regular community events geared towards fundraising in 2018. Improvements are not possible without donations and good volunteers. Please contact any LPOA board member to volunteer or submit project ideas for approval.
