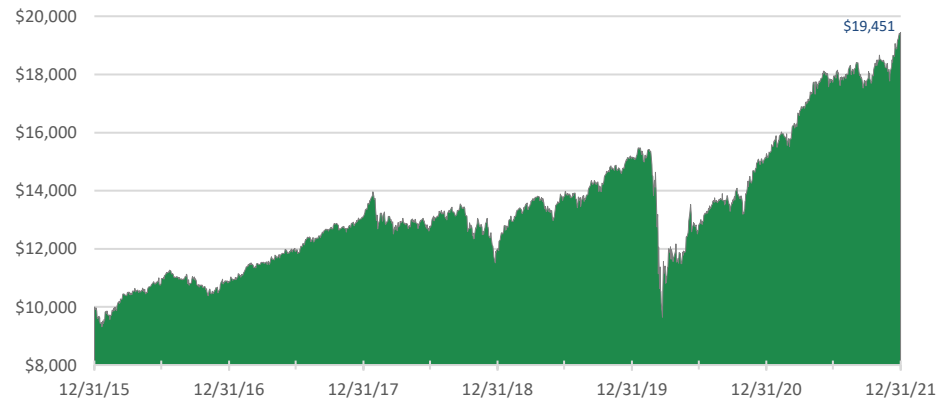

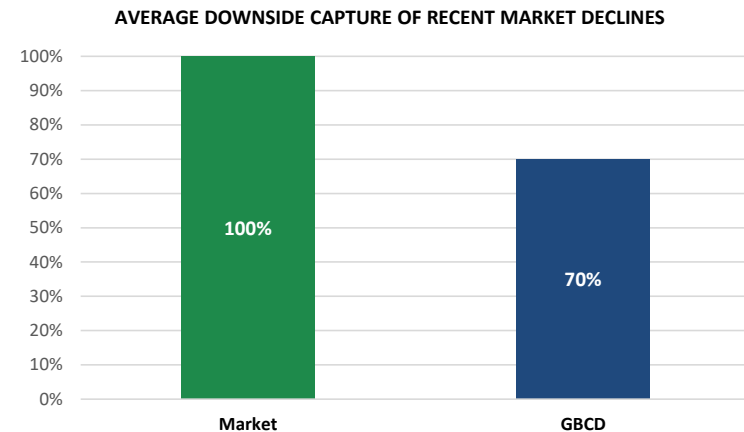
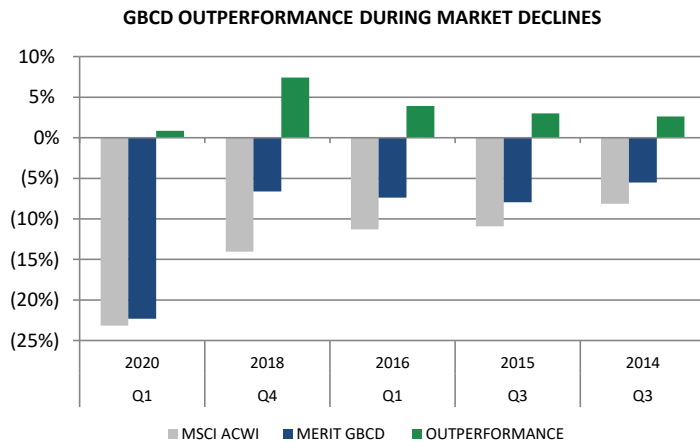
HISTORICAL PERFORMANCE ANALYSIS

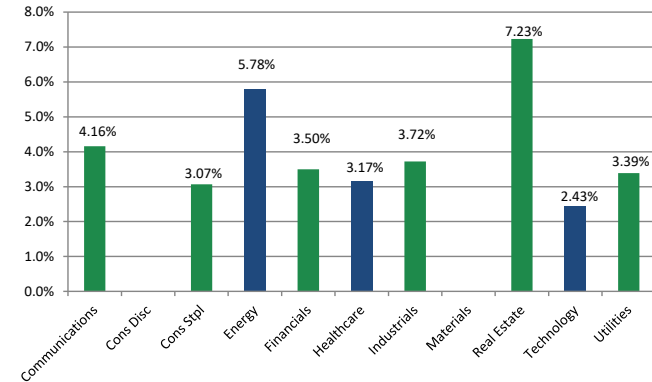
DIVIDEND YIELD & RISK METRICS

The Global Blue Chip Dividend Strategy offers a higher yield and exhibits significantly lower volatility & risk

DIVIDEND METRICS

- GBCD yield of 4.1% is higher than U.S./Int'l equity indexes of 1.3/2.5%
- GBCD yield of 4.1% is higher than the IG Corp Bond index of 2.2%
- Solid dividend yields across all sectors ranging from 2.4% to 7.2%
- Strong dividend income with equity upside and inflation hedge

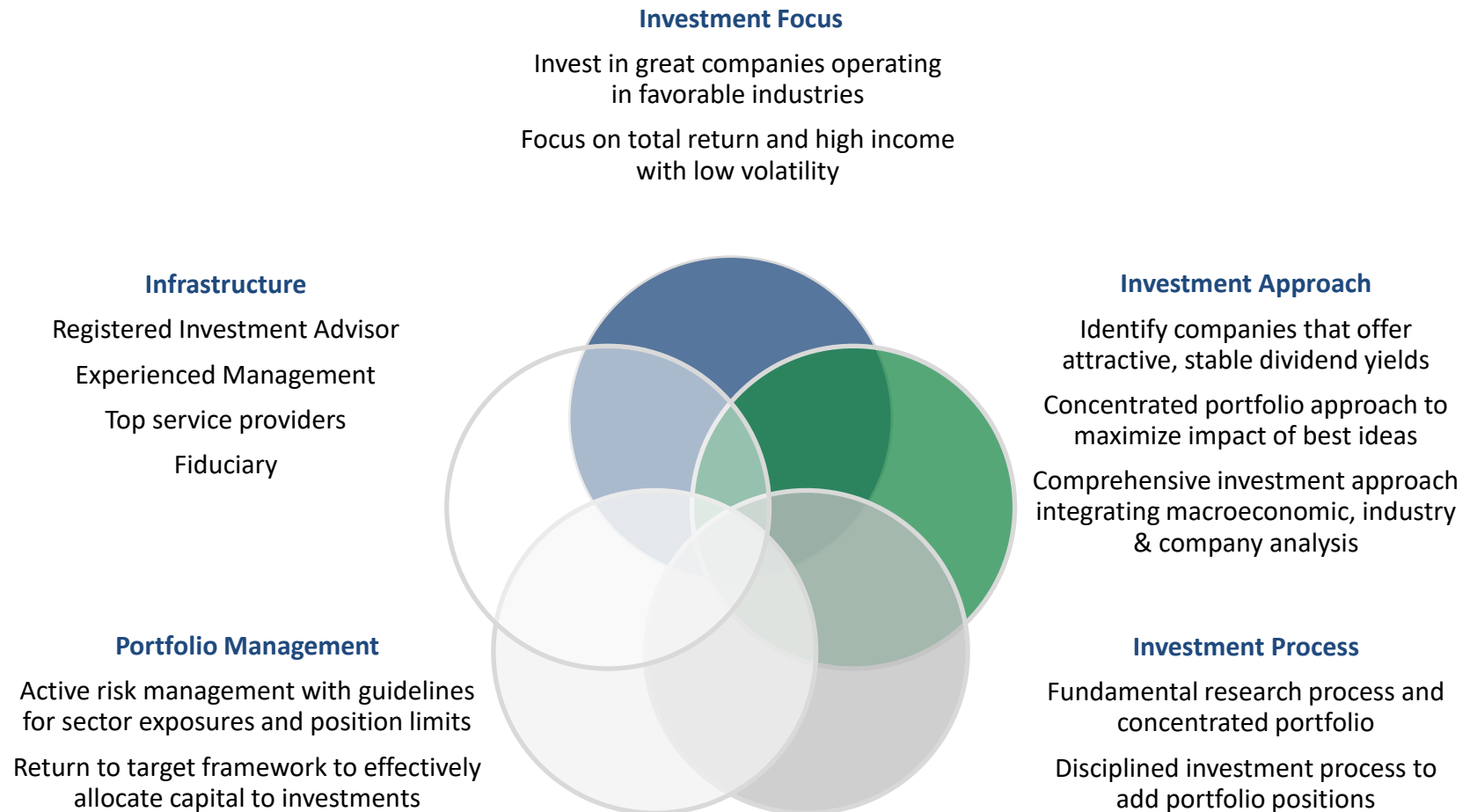
