MISSOURI

Originally part of the Louisiana purchase, the Missouri Territory was created when Louisiana was separated from it to become a state. Missouri won statehood in its own right in 1821, and in the following year was organized as a single district with full federal jurisdiction.

MO.WD.01 is the original judgeship (see Judge Peck's succession line), and served the entire state until its reorganization into the Eastern and Western Districts in 1857.⁴ The division authorized a separate judge for the Eastern District. The 1922 judgeship legislation authorized a temporary position for each district (MO.ED.02 and MO.WD.02), and both positions were converted to permanent in 1935.⁵ In 1990, MO.ED.07 also was created as a temporary line. Seven years later its authorizing legislation was amended to allow vacancies on this court to be filled until ten years after the confirmation of Judge Stohr,⁶ at which point the first such vacancy will go unfilled.

MO.EWD.01 was created in 1936, and MO.EWD.02 was authorized as a temporary, "roving," line in 1942 that subsequently was converted in 1954. In each case, the position was created to serve both districts, but unlike most transient lines these were never assigned permanently to a regular judicial district.

Missouri is a member of the Eighth Circuit with fourteen judges, distributed as follows: six (plus a temporary) in the Eastern District, five in the Western District, and two transient positions that serve both districts.
