Things to Remember

The Volusia flagler CoC conducted Planning meetings prior to the release of the NOFA to discuss reallocation and movement towards PSH. At the Planning meeting held on 9/11/15, the Domestic Abuse Council formally announced that they were seeking other funding opportunities for their transitional housing program and would not be renewing their HUD funded transitional housing grant. The domestic abuse Council therefore voluntarily reallocated this grant funding to fund new projects as determined by need in accordance with the VFCoC 2015-16 Strategic Plan.

VFCoC approved reallocation of this grant funding.

The Coc Applications Committee reviewed and ranked all new and renewal applications in accordance with guidelines and priorities as outlined by HUD's "Opening Doors" and as applicable to the CoC's strategic plan. In accordance with the Applications Policy and Procedure grants were awarded funding based on project ranking in order of the rank as determined by their score. The First Step Transitional Housing program ranked 16th out of 17 and therefore the full funding went beyond the funding amount allocated in the ARD, therefore the CoC made the decision to retain the program at a reduced funding amount within the HUD ARD for our CoC.
