Mercedes-- I have included Senator Rubio's response below my copy of the last letter to you (from this weekend). The Senator's response included the words: "*computer hacking and some suspicious deaths.*" Please note that I was also very concerned about the illnesses some of the employees currently have. These two employees also happened to have been mentioned in my complaints, as detailed in my letter below. In the letter to you I also mentioned the threat to my health by manager Stuart Herna. I imagine he might not lie about this to the FBI. However, he has subsequently claimed he does not recall the conversation to me. There are also other concerning deaths besides what I have previously noted.

Hi Mercedes,

In looking over that last email I had attempted to send you yesterday, I think you already have most of that important information. This initially went to UM's President Frenk but I have already sent you the most important concerns from that including suspicious deaths, the threat to my health, and **concern for two UM workers who are now (possibly suspiciously) ill, one very much so.** One of them ([REDACTED]) has, I am sure, information on my computer hacking, specifically my **remotely and falsely started credentialing exam** last year, and the other ([REDACTED]) was mentioned in regards to other complaints including the **deliberately rerouted printing requests (from my printer to hers).** You have most of those hacking complaints. What I had also sent President Frenk was the documentation for the multiple UM Tumor Registry cancer cases not completed for years until I saw them (they were falsely marked as non-reportable). These I saw and reported in 2014 after being moved to working on SCCC (Sylvester) cases. I also reported patient "follow-up" being falsely documented as complete when none to very little patient information was even researched (at most a date of contact). In many instances "phone call" was the method of contact but even that was never made, as we were instructed in 2008 by Susana Arias Morales, a supervisor who was rehired in the last year or two. Manager Stuart Herna was in the room at the time. I refused to do this. This causes cancer cases and treatments to be missed for years, which I had reported in 2011 and 2012 (what I knew about) that had occurred in 2008, 2009, 2010. One 2009 case was missing two of the patient's cancers for 4 years until I saw the case in 2012. I was moved back to UMH cases after reporting this -- they are all incidental findings on my part. We work from pages of patient lists, 35-40 patients per page for both abstracting and follow-up. Cases and treatments are required by law within 6 months of the patient visit. In 2010 a volunteer gave me 23 pages of this same type of "follow-up" she was asked to do (put that a call was made but none actually were --as we were instructed to do in 2008) ... She left UM after a few

short months. Anyway, Herna told me, when he threatened this past February that I was not as well health-wise as I thought, that I "have complained about a lot of people" ... I told him, "that is attempted murder" and he told me that I "have to prove it" ... He began the conversation by telling me that [REDACTED] was very ill. I only recently learned that she indeed was.

So, these are extremely serious concerns and the FBI, through Senator Nelson, had this information I am sure at least three months ago. I gave them names of individuals I thought were involved and I would think there should have been arrests by now. Please convey to Senator Rubio that I am concerned about the time lapse and health of at least two of the people that have information regarding their own illness history, including procedures they may have had done where there may have been malicious actions, and information regarding the severe hacking, including whom or what entity was or may be responsible. The hacking is high-level and clearly, irrefutably documented (you have these PDFs from prior emails) ...

As always, I am glad to answer any further questions.

Dear Officer Jeanniton,

I have tried to reach you to touch base about my complaint from this past Saturday 8/6. When will you be available to speak with? I had complained about someone calling as me to Bethesda East Hospital that Saturday morning. This person had spoken with Amy, one of the nurses there who had overseen my cousin Joan. I had mentioned other concerns to you as well. [REDACTED]

As mentioned, because of concerns at my work (University of Miami [UM] medical facility), including severe retaliation against me targeted also at those around me, I am very concerned about my cousin's safety. (I have reported cancer data manipulations we were told to do and other concerns over the past several years.) My cousin lives by herself although she has known this person [REDACTED]. I was up to see Joan late in the day Sunday 8/7 and they had put restraints on her stating that she had tried to take her catheter out early in the morning Sunday (8/7). My cousin did not recall that she had tried to take the catheter out and is not sure what happened. The nurse Amy stated that my cousin was "confused". However, Joan knew me right away, knew the hospital she was at, spoke of family, and conversed with me and another person on the phone. I do not know what drugs she is being given. My cousin is a kind, quiet person and tries to take care of her health, not injure herself.

I also mentioned that two co-workers of mine mentioned in my UM complaints, young women comparatively, now have cancer. My life has been threatened at work (that something malicious occurred at a surgery), and now there is concern that my cousin Joan has cancer? She has been down to UM for medical care on a number of occasions for another health issue. I have also been subjected to severe hacking of my work and home computer and home phone -- many instances documented with UM, local police, and other law enforcement. My contact lists have been compromised and call logs hacked. An ex-friend (Rebecca Butler) took family pictures and taped comments at a gathering in January and has passed them to some unknown source. [REDACTED]

[REDACTED] Details are with law enforcement. There is probably about 150+ pages of documentation on my concerns sent to a number of entities, Senator Rubio most recently. So, there are many very serious issues, including other suspicious deaths, should you wish to know more.
