**Approve minutes for May 30, 2019:**

- Minutes from May 30, 2019 meeting were approved and signed by the Board unanimously.

**Town Plan Update and Historical Interview:**

- Two of the Zoning Board members, Sam Thurston and Keith Christiansen, joined the meeting to discuss updating the Town Plan. Sam had gone over a list of Goals and Objectives from the previous plan and asked the Board to think about things they may want to add to the list. Sam had the Selectboard Clerk make copies of the Goals and Objectives page for the Board to review for themselves. More discussion on this plan will be at a later date.

- Sam Thurston, also a Historical Society member, introduced Bethany Dunbar to the Board, who came to interview the Selectboard Members. She has already interviewed other people in the Town of Lowell for Town history. The examples of the questions she had asked are as follows:
  1. How has the Town changed?
  2. How has being a Board member changed?
  3. How has the School System changed over time?
  4. Has Town participation changed?
  5. What makes Lowell special or different?
- Sam gave the Selectboard Clerk an announcement for an upcoming event for the Historical Society to share in the minutes. The following is the information for the Event call “Lowell Story Afternoon”:

- Calvin had the Board sign a letter of intent for the next grant to be applied for on the better back roads.
- Calvin noted to the Board that the crushing in the pit would be finished by the end of this week.
