


ORDINANCE NO. 357


BE IT ORDAINED BY THE CITY COUNCIL, of the City of Rolla, North Dakota that the following sums of money be and they are levied upon all the taxpayers property in the City of Rolla North Dakota, such tax levies being for the following purpose to wit:

RESOLUTION

WHEREAS, the City of Rolla has established Ordinance No. 358 pursuant to 40-57.3-01 of the North Dakota Century Code to impose and collect a 2 per cent sales tax for the purposes therein provided.

NOW, THEREFORE, pursuance to said Ordinance No. 357 and effective April 2, 1992, the City of Rolla does hereby impose a city tax of 2 percent upon the gross receipts of retailers on the leasing or renting of hotel, motel or tourist court accommodations within the City of Rolla, of less than thirty consecutive calendar days or one month.

IT IS FURTHER RESOLVED that a copy of this resolution, Ordinance No. 357, and section 40-57.3-01 of the North Dakota Century Code be furnished to each retailer as defined in said act by the City.

IT IS FURTHER RESOLVED that there is hereby established a "Visitors' Promotion Fund" into which shall be deposited all proceeds received by the City from the levy and collection of the City Lodging Tax. Disbursements from said fund shall be used to promote, encourage, and attract visitors to come to the city and use the travel and tourism facilities within the City.

IT IS FURTHER RESOLVED that a "Visitors' Committee" shall be established by the City to serve as an advisory committee to the city governing body in administering the proceeds from the tax. The Committee shall consist of five members appointed by the City Council to serve without compensation except reimbursement for necessary expenses. Committee members shall serve for a term of four years. Vacancies shall be filled in the same manner as the initial appointment. The Committee shall elect a chairperson and a vice chairperson from among its members to serve for a term of two years.


