There were two Board of Directors meeting which consisted of very lengthy agendas.

- Due to no regular meetings the member applications were reviewed and accepted 9 from the waiting list and the 9 presented that night.
- It was decided to hold the August regular meeting outside in the pavilion weather permitting and following the regs.
- Any new member applications would be sent to Charlie.
- The fall Feast was cancelled but Mark Brockett continued to handle a raffle via mail.
- The nominations were put on a contingent plan, if unable to hold in November it will be done in the spring.
- There was a lengthy discussion re: 'Inner Board Member' lack of communication. Because this needs to be a joint effort of all involved, Earl Lindfield volunteered to take the task of informing and follow up of all relevant communications.
