Trip Polices...Please understand the following policies are in effect for all ASC trips and by signing this contract, you agree to follow such policies.

All trip participants must be current members by December 1.

Trip sign ups are restricted to club members from the previous year for the first 30 days .

Trip package will allow flexibility in package no for air, number of lift tickets and age discounts. *No partial night packages will be sold.*

Everyone staying the lodging property must a registered person on the trip....no overnight guests. Special considerations may be requested, with prior board approval, and determined compensation will be decided. The approval of this special request must be agreed upon by all room or condo mates. Unregistered guests will be asked to immediate leave the property.

It is understood that a credit card will be held by the lodging property for all incidentals or damage.

Inappropriate behavior at any point during the trip (including excessive complaints filed by other trip participants) and violations of the trip policies will not be tolerated and acted upon immediately. The concern will then be brought to the trip committee for review with a follow up report and recommendation to the board.

Only registered trip participants can order tickets. Each participant may request ONE extra day ticket at a discount rate (if mountain and vendor agree) for a friend who might live near our trip location. This extra ticket must be ordered and paid for with the final trip payment.

Any deviation of the proposed travels plans during the trip will be at the discretion of the trip leader(s), with input from board members and trip committee on the trip, as well as input from travelers, as needed. In the event of a safety issue, the input from transportation company or lodging property's decision will be strongly considered.

If you must cancel your reservation, ASC reserves the right to keep the first \$25.00 due to costs that can not be reimbursed. After October 15th, any cancellations reimbursement will be through trip cancellation insurance only. Trip Cancellation/Interruption insurance is available & highly recommended. We do not provide the trip insurance as part of this package.

RESPONSIBILITY STATEMENT: The payment of the required deposit or any partial or full payment hereunder shall constitute consent and agreement to the provisions herein. Albany Ski Club, its agents, servants and employees shall not be responsible for personal injuries or property damage, loss or delay, or change of itinerary incurred by any person or tour participant arising out of the act of negligence of any direct or supplemental air carrier, hotel or other persons rendering any of these services, or accommodations offered in these tours; nor shall Albany Ski Club be responsible for any injuries, death, damage, loss or delay in any means of the transportation or by reason of any event beyond the actual control of Albany Ski Club, or of any agent or supplier or due to force majeure. Albany Ski Club reserves the right to decline or accept or to retain any person as a member of a trip, or to cancel a trip. Tour participants shall ski at their own risk. Tour participants acknowledge that they are aware of the fact that skiing and other activities in which they may elect to participate while on the tour involve inherent risks and danger of injury or death. Tour participants shall participate in such activities at their own risk and indemnify and hold Albany Ski Club, their employees and agents harmless in the event of injury or death. If the contract between Albany Ski Club and the participant and/or the contract between Albany Ski Club and the air carrier or vendor is cancelled for any reason whatsoever, all partial or full payments made for the trip will be refunded in their entirety, without further obligation of the part of Albany Ski Club may substitute hotels for other hotels of similar category or change schedules should the circumstance so demand. If time permits, Albany Ski Club will provide notification of any such changes. In the event of a change in the itinerary necessitated by factors or conditions beyond the control of Albany Ski Club, no refund can be made nor will

credit be allowed, provided that, in the event of such change in itinerary, Albany Ski Club shall provide accommodations and services of comparable quality and standards. Any such change shall not modify the cancellation provisions herein. No credit will be allowed or refund provided for any services provided in the Itinerary and Conditions List should any such services not be utilized by tour members. Availability of refunds for air transportation included in a tour and additional transportation costs for a person who does not utilize the air transportation part of a tour will vary with the type of transportation, and the point at which transportation is not used. The person signing this document on behalf of the organization does attest that he or she has been empowered by the said Organization to issue and sign contract on behalf of the Organization. If the Organization is not a legal entity, then the person signing is accepting personal responsibility for the items herein. This document is the sole agreement between the parties. Any changes must be in writing and reference this agreement.
