Secretarial Report:

Motion made by Dennis Beck 2nd Kevin Hite to accept the Regular meeting minutes dated September 21st, 2020, Treasurers Report, Unpaid Bills Detail and an Additional Unpaid Bills as presented. Roll call, all in favor, Motion passed.

Engineers Report:

As Discussed,

- Deborah & Donald Beck Sewer Line Extension: In Accordance to the Developers Agreement, a bill of Sale will need to be drafted and sent to the Becks for signatures, execution of bill of sale is the final step of the Developer's Agreement
- Stream bank stabilization project- construction of the Stream Bank Stabilization Project began August 31st, 2020 and completed on September 14th, 2020. Pay Application #1 in the amount of \$56,761.50, contractor was paid.
- As discussed in the April meeting, the stream bank destabilization and erosion area increased in size, due to the increased size, the contractor needed to extend the project areas in order to find stable material. Pay application #2 in the amount of \$20,241.76 includes Change Order #1. This is the final payment request for the stream bank destabilization.
- EADS provided assistance with submitting Pay Request #1 to the DCED in the amount of \$56,761.50. The authority was reimbursed \$48,247.28 due to the 15%

match required in the grant agreement. Pay request #2 is prepared for the amount of \$3,238.50.

Replacement/upgrade of control Panels at the WWTP Grant for Small Sewer and Water was approved on August 17th, 2020 for \$81,532.00 with CMSA 15% Match, grant agreement has been executed by the Authority, awaiting final agreement has been received. Engineers Agreement has been submitted for the Authority's review.

Motion made by Dennis Beck 2nd Rita Butterbaugh to execute Pay Requisition #2 in the amount of \$20,241.76, which includes change order #1. Roll call, all in favor, Motion passed.

Motion made by Kevin Hite 2nd Edward Myers to sign the Payment Requestion #2 form for the Commonwealth Financing Authority. Roll call, all in favor, Motion passed.

Motion made by Dennis Beck 2nd Edward Myers to approve the Engineers Agreement with the EADS Group for the second grant from the Commonwealth Financing Authority. Roll call, all in favor, Motion passed.

- ➢ Grinder pump ordered for new Valley View customers plus spare core.
- Press bearings problematic, tripping the control panel, Cambria Systems called to fix the problem, on stock -bearings replaced sludge press working well.
- Problematic grinder pump repaired along Valley View- pressure switch was bad, grinder pump has been in operation for 10 months, still under warranty, motor switched out for customer, old motor being repaired.
- UV System- ballast control knocked out due to power failure-ballast under partial warranty- CMSA cost is \$300.00 for new ballast.
- > Flushing of the sewer main- general maintenance.
- Manholes under the Valley View Pressure Line are leaking
- Sump Pump at plant is problematic- new- \$600.00 estimated repair cost \$400.00.
