A TRAILER BOATER is described as a primary member who does not lease/sublease a shore space or Club dock space, who trailers a boat onto Club property and launches it from a Club ramp as a primary method of boating in and out of the Club.

USE OF RAMPS FOR TRAIERED WATERCRAFT is available, at no additional charge, to all primary members that lease/sublease a shore or dock space only. If you are a trailer boater only, you **MUST** pay the trailer boater fee as listed on the front of the invoice/application.

SHORE SPACES are 10' and 20' wide. Only one boat may be in a 10' space and 2 boats in a 20' space. It is your responsibility to keep all of your equipment (boats, docks, etc.) maintained and in good condition, and in your space. All members leasing a shore space will be notified with any issues. Remember, you may sublease a 10' space, both 10' halves of a 20' space and, if so, are responsible for the entire space. Any member subleasing a space must be a member that has paid for their membership and signed the invoice/application. A sublesser may not sign for a primary member at any time.

CLUB DOCKS are available if open. Members must be on a waiting list to obtain a dock space. Forms are available in the office. All members with boats on Club docks are not permitted to use screw eye bolts (exception: old docks). The fine for this infraction is \$5.00 per bolt. The Club will supply you with regulation tie downs (see manager or employees). In case of 5-1/2 feet of water or higher, members will receive a message to remove their boats from Club docks. Failure to immediately remove boats will result in a \$100.00 fee if Club personnel are required to do so. If Club personnel are required to move your boat from Club docks, you are responsible for any damage which may occur.

CLUB NUMBERS must be visible on all watercraft, trailers, and docks located on Club grounds (in or out of the water). See office for free numbers.

PARKING DECALS will be distributed to all members/guests once the vehicle registration assigned to that decal is turned into the manager. One parking decal will be issued to each primary member once all dues are paid and the invoice/application is signed by the primary member only. Decals must be placed on the mirror or laid on the dash so that they can be seen and read from the outside. Your vehicle's license plate number must be placed on the decal, and the decal license plate number must match the license plate number of the vehicle in which the decal is placed. Decals may not be transferred but, rather, only one vehicle per decal may be on club property at any given time. Additional decals are available for purchase. All parking decals are for the 2021 boating season only. Legal parking decals must be displayed in vehicles no later than May 25th. If you drive onto club grounds after May 25th without a parking decal or an illegal parking decal, you will be required to pay a daily fee to park and/or launch your boat. No decals will be issued during holiday weekends. You will incur additional fees if you forget or misplace your parking decal. You will also incur additional fees if your decal is used in a vehicle bearing a license plate not listed on your decal.

USE OF CLUB EQUIPMENT is available to all members. You may use, at no additional cost, trailers, hitches, the forklift (with proof of certification), and any equipment owned by the Club that is used in common by members for the purpose of boating. Members are not permitted to use Club equipment that is related to property maintenance or business functions such as lawnmowers, computers, etc. See Club Manager for equipment available for use by all members. Each member accepts full responsibility and liability for equipment borrowed and any damage to it or caused by it.

YOU, THE PRIMARY MEMBER, are responsible for your own and your guests' fines and conduct. All fines are due within 10 calendar days from the date issued. Please be sure that all of your guests are made aware of the club rules prior to their entering club property. Please pay particular attention to parking issues. Guests do have designated parking areas and are not permitted to park in areas reserved for members. Please be sure your guests understand that you are responsible for their conduct and request that they conduct themselves in a manner that mirrors your own. Please inform your guests of your Club number.

It is the responsibility of each member to know the By-laws, Rules and Regulations, and all payment due dates.
