State EMS Update – Don Kimlicka	 The eLiscensing Operational Plan feature will be online soon. Services are encouraged to update their plans in the new tool but not required to unless they are upgrading or having some other form of change to their service The flex grant release has been complicated and frustrating for all. The money is Federal dollars so there is additional paperwork & processes to release them. The DHS EMS website has additional information on it and will be updated regularly with important information for recipients The MCI template plan is under review The error in the rule requiring AEMTs to have ACLS has been fixed. EMS Advisor Board meetings are Dec 6 & 7. Don has jump bags available for first responders

UNANIMOUSLY APPROVED Michael discussed that some EMS leaders in the area are looking at the idea of bringing the National EMS Management Association Field Training Officer training program to the region. Process improvement committee	 Has not met. Will look at a next meeting time. Possibly after the next general meeting. Was looking at establishing some benchmarks related to ED Length of Stay. May update the PI tool. Collected trauma team activation criteria from many of the hospitals in the region. Michael created a comparison grid. Will hold a trauma coordinator meeting after the next general meeting Will ask coordinators to bring their PI forms
Out of Hospital Committee	Has not met. Will set up a meeting.

Injury Prevention Committee	 May look at setting up a hospital capacity/capability grid to provide information to EMS providers, particularly when they are called into an area they are not familiar with. Discussed the challenge of keeping it current given the fluid status of hospital bed availability and services offered. MCI Class – March 4 Michael is sending laminated Trauma Field Triage Guideline cards to each service. Will set up a meeting. Would welcome new members
	 Amanda discussed a new project they are working on in Marathon County to address patients that call multiple times for falls
Conference Planning Committee	 Group has met once and working on a second meeting. Have a few new EMS members, would still like to have representatives from Level III/IV hospitals. Looking for speaker/topic ideas Discussing accreditation for EMS so that the CEUs can be used for Michigan licenses
Position Statement – TXA	 Group reviewed the draft position statement on the administration of TXA. Document had been posted with the agenda prior to the meeting. Michael noted that the statement should read IO route in addition to IV. Motion by Dr. Clark to approve the position statement as amended. Second by Steen. Discussion: Sara noted that she had heard of some areas where the 1 gram infusion was being given as a bolus right away. This had created an issue when EMS gave a 2 gram bolus but the hospital did not know it and gave the 1 gram infusion. Neither level II in our area are currently considering a 2 gram bolus. We can revisit the position statement in the future if that changes. UNANIMOUSLY APPROVED
Other business	 Michael discussed the statutory language that Margaret identified with addition PI confidentiality protection. We will use this to get our case reviews going again.
