A CITY OF NEWTON ORDINANCE TO ENTER INTO A SUBLEASE AGREEMENT BETWEEN SAINT THOMAS THE APOSTLE PARISH, AS SUBLESSOR, AND THE CITY OF NEWTON, ILLINOIS, AS SUBLESSEE INCREASING PAYMENTS FOR WATER WELLS

WHEREAS, the CITY OF NEWTON is the beneficiary of a certain Lease

Agreement entered into by and between SAINT THOMAS THE APOSTLE PARISH and
the CITY OF NEWTON dated May 14, 1990 and amendment thereto dated March 25,
2009, and

WHEREAS, it is the best interest of the CITY OF NEWTON to enter into a new payment agreement with respect thereto; and

WHEREAS, the Land which is the subject of the original Lease Agreement is currently owned by the ROMAN CATHOLIC DIOCESE OF SPRINGFIELD ILLINOIS TRUSTEE CORPORATION, an Illinois Not for Profit Corporation, as Trustee and is Leased to SAINT THOMAS THE APOSTLE PARISH of NEWTON ILLINOIS, a Not-for-Profit Corporation; and

NOW THEREFORE, BE IT ORDAINED by the City Council of the CITY OF NEWTON, Illinois as follows:

- 1. The CITY will enter into a new SUBLEASE AGREEMENT between SAINT THOMAS THE APOSTLE PARISH, as Sublessor and the CITY OF NEWTON as Sublessee, a copy of which is attached hereto and incorporated herein by this reference as Exhibit A.
- 2. The Mayor of the CITY OF NEWTON and the Clerk of the CITY OF NEWTON are hereby authorized to enter into said SUBLEASE, upon the signature thereto by FATHER PAWEL LUCZAK of SAINT THOMAS THE APOSTLE PARISH.
- Except as set forth in said SUBLEASE all original terms of LEASE
 AGREEMENT dated May 14, 1990 and AMENDMENT thereto dated March 25, 2009
 shall remain in full force and effect.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

SUBLESSOR, AND THE CITY OF NEWTON, ILLINOIS, AS SUBLESSEE

WHEREAS, SAINT THOMAS THE APOSTLE PARISH, is Lessee from SAINT THOMAS THE APOSTLE PARISH TRUST c/o THE ROMAN CATHOLIC DIOCESE OF SPRINGFIELD as Trustee of the Land described on Exhibit A attached hereto and incorporated herein by this reference;

WHEREAS, there is currently located upon Land which is the subject hereof, four (4) water wells for which the CITY OF NEWTON has in the past been paying the sum of \$500 per well per year;

WHEREAS, it is the desire of SAINT THOMAS THE APOSTLE PARISH as Sublessor to enter into a sublease with the CITY OF NEWTON in order to modify and increase the amount of money paid by the CITY OF NEWTON per year, per well.

NOW, THEREFORE, in consideration of One Dollar (\$1.00), paid by CITY OF NEWTON as Sub-lessee to SAINT THOMAS THE APOSTLE PARISH as Lessee from SAINT THOMAS THE APOSTLE PARISH, c/o ROMAN CATHOLIC DIOCESE OF

SPRINGFIELD, Trustee and for other good and valuable considerations, the receipt and sufficiency which is hereby acknowledged the parties hereto agree as follows:

- 1. THE CITY OF NEWTON as Sub-lessee agrees to pay to Sub-lessor, SAINT THOMAS THE APOSTLE PARISH, annually the sum of \$1,000.00 per well per year for the four (4) existing wells and for each new well hereinafter completed, if any, on the Lease Land.
- 2. Except as herein before set forth, the original terms of the Lease Agreement entered into by and between SAINT THOMAS THE APOSTLE PARISH and the CITY OF NEWTON, dated May 14, 1990 and Amendment thereto dated March 25, 2009, except as modified herein remain in full force and effect according to their original terms.
