### D. Consider and Discuss Resolution No 2016-04-25-01

A RESOLUTION OF THE CITY OF CISCO, TEXAS, FINDING THAT AEP TEXAS NORTH COMPANY'S APPLICATION FOR APPROVAL OF A DISTRIBUTION COST RECOVERY FACTOR TO INCREASE DISTRIBUTION RATES WITHIN THE CITY SHOULD BE DENIED; FINDING THAT THE CITY'S REASONABLE RATE CASE EXPENSES SHALL BE REIMBURSED BY THE COMPANY; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION IS PASSES IS OPEN TO THE PUBLIS AS REQUIRED BY LAW; REQUIRING NOTICE OF THIS RESLUTION TO THE COMPANY AND LEGAL COUNSEL.

Mr. Archer explained that AEP is filing for a cost recovery to be added to electric bills and as a member of the cooperative, we can deny the rate increase to our customers.

Mayor Pro Tem Weger informed the Council that he had recently attended training on the Public Information Act and found that the city should not be using personal emails for city business so email addresses have been set up for each Councilmember to use for city business.

Councilmember Douglas spoke about the Folklife Festival saying that numbers were down this year, but the Civic League was hoping to make some changes to the festival to increase participation for the next year.

Councilmember Green asked about the items the city was going to auction and Mr. Archer explained that all items were currently on the govdeals.com website. He said that not all the items met reserve the first time they went to auction so they were up there for a second time.

Councilmember Douglas inquired about trash pickup at the lake noting that the dumpsters were full last weekend. Mr. Archer commented that the trash was picked up each Monday. He further stated that restroom facilities will be placed at the point as well as updated signage.

Councilmember Green asked if any more mention had been made regarding the annexation of the lake lots. Mr. Archer explained that he would be attending an annexation workshop in May and discussion of this topic would probably take place after that information was gathered.

Councilmember Boles asked if street repair was continuing to which Mr. Archer commented in the affirmative. He went on to say that the city had gotten millings from Brownwood to use in street repair.

explained that there was only one employee in that department with one part time position cur	rently open.
Also budgeted are two seasonal employees so it will be a constant throughout the summer.
