Gordon Brann and the Select Board reviewed the 2018 and 2019 Library budget.

Harold said that he needed two new chainsaws and has priced them approximately about \$350.00 each.

Josh Stevens and Carl Rubinchuk were in to discuss the plans for the new Highway vehicle shed.
