#### **Constitution& Articles**

- 1. Name: Michelle Peacock Foundation
- 2. Objects
- 2.1 Promote awareness of cervical cancer, by associating voluntary organisations and other charities in a common effort to advance funds to named charities
  - (b) Raise awareness among young people of the importance of spotting the signs of cervical cancer

#### 2.2 Powers

- 2.3 **(a)** In furtherance of the above objects, but not further or otherwise, the foundation may:
  - (b) Organise or assist in organising meeting, fund raising event, exhibitions and publish books, reports and periodicals or other documents or information.
  - (c) Obtain, collect and receive money by way of donations, bequests, legacies or other lawful method, provided the foundation shall not undertake any permanent trading activities.
  - (d) Purchase, take on lease or in exchange, hire or otherwise acquire any real or personal property and any rights and privileges necessary for the promotion of the above objectives
  - (e) Employ and pay any person or persons, not being foundation to supervise, organise and carry on the work of the foundation and make all reasonable and necessary provision for the payment of remuneration to employees
  - (f) Do all such other lawful things as may be necessary for the attainment of the above objectives or any of them

# 3 Membership

- 3.1 The Foundation will accept members and shall be open to the following, irrespective of ethnic identity, disability, nationality, sexual orientation, religion or political opinion.
  - (a) Well-wishers anywhere, or persons who, in the opinion of the foundation have special knowledge or experience to offer the foundation shall be members, without voting rights.

### Management

4.1 The affairs of the foundation shall be managed by a committee know as the "Founder Group"

- 4.2 Chairperson, Vice Chairperson and Treasurer.
- 4.3 The "Founder Group" will meet not less than three times per year.

## 5. Functions of the Founder Group

- (a) Make such decisions as they consider appropriate for the efficient conduct of the foundation.
  - (b) Appoint staff as they consider necessary on such terms that benefit the foundation business
- (c) Oversee and approve or disapprove any foundation business
- (d) Ensure that foundation activities are of universal approval

#### 6. Finance

- 6.1 All such monies raised by or on behalf of the Michelle Peacock foundation shall be applied to further the objects of the foundation and for no other purpose.
- 6.2 The treasurer shall keep proper accounts for the finances of the foundation and shall delegate responsibility for preparing an annual statement of accounts for the meeting of the "Founder Group"
- 6.3 The foundation shall open a bank account or accounts in the name of Michelle peacock foundation and shall specify two members of the founder group to authorise to sign cheques or withdrawal on behalf of the foundation

### 7. Dissolution

If for any reason the Founder Group shall decide to dissolve the foundation they shall call a meeting of the said group members.

All assets of the foundation which remain after the satisfaction of all debts and liabilities shall be passed on to another charitable association as the founding group shall decide
