Rules: 1. If you have bowled a sanctioned 600 series and have validation from your league secretary, you are eligible to join the Tacoma 600 Club. This tournament is open to all women who are Tacoma 600 Club Members with a 2018-2019 USBC card. You do not have to be a South Sound USBC member to become a member.

2. Tournament will be certified and winning scores will consist of 3 games plus handicap. You will bowl 4 games and the lowest score will be dropped. **Format is 9 pin no tap.**

3. Entry closing date is 1:00 pm on April 8, 2018 unless the schedule is filled sooner.

4. Handicap is 90% of the difference between 210 and highest book average.

5. Prize fund will be returned 100% with a prize fund ratio of at least 1 for 6. Please note, the prize fund has been increased for this year. Bowling is costing 25cents per game more.

6. Total entry fee must be submitted with entry form and is non-refundable.

7. Entrants will use their highest USBC sanctioned league average based on at least 21 games for the 2017-2018 season, or summer league average. If entrant does not have a 2017-2018 average, then will use their highest current sanctioned league average for the 2018-2019 season with at least 9 games at the time of the tournament. If no average, will bowl scratch.

8. Rule 319-1-3: It is the entrant's responsibility to verify the accuracy of her average in handicap tournaments, whether originally submitted by the entrant, her team captain, or others. Failure to use the proper average will disqualify the score if submitted average is lower than the actual average which would result in a higher handicap. Prize winnings will be based on the submitted average, if it is higher than the actual average.

9. Rule 329 will apply. Scoring errors must be corrected within 24 hours to the Tournament Manager.

10. There will be two divisions: Division 1: 170 Ave and above; Division 2: 169 Ave and below
