January 24, 2018

President Jeneen reviewed the 2012 Tsunami Report with select findings as follows:

The Chain of Command was unclear.

Residents that want training on Disaster Actions do not know where or how to get it, nor do they know how to participate.

Follow-up training for those who are CERT or other skills is minimal and insufficient.

The challenge and principal task for the CEC is to help to remedy these and other shortcomings.

General Principles:

- Establish the volunteer groups. There are already many operating groups within the county. The level of organization varies widely from Branch to Branch.
- Identify leaders of each organization. Formally acknowledge them and facilitate person-to-person contacts, following the concept of "get to know each other now, so we won't have to do it during a disaster."
- Identify and prioritize shortcomings in organization, training and equipment.
- Train together.
- Each group needs to plan and execute their own vetting and training.

Note: Staffing the EOC will be done by Chad and County Employees, due to the way funding comes to reimburse OES, instead of using ICS qualified volunteers. OES will continue to offer ICS classes.

The Board introduces themselves to the membership.

The Advisors were introduced to the membership.

Non Profit Status.

Board decision to maintain the 501c3 status for liability and potential fund raising. Peggy Wargo has familiarity with charitable trusts and will oversee it for the time being.

By-Laws.

Pat O'Coffey will review the by-laws and provide a proposed draft to the Board.

Website.

The website is rudimentary but will be reviewed by Pat O'Coffey.
